

Inleiding

In zijn boek “Geen Geloof zonder Bewijs” haalt Pé de Bruin heel wat heilige huisjes omver. Best een boeiend boek dat Pé na 10 jaar onafhankelijke studie van de Bijbel als journalist heeft geschreven. Het is alleen heel erg jammer dat Pé in dezelfde fout valt die zeer veel christenen en theologen maken door geen onderscheid te maken tussen Joden en Israelieten. Pé ziet Abraham als de stamvader der joden. Alle beloften die in de Bijbel voor Israel staan geeft Pé zonder schroom aan de joden. De joden zullen volgens Pé eerst over de hele aarde verstrooid worden om daarna terug te keren naar het land Israels. Jeruzalem zal volgens Pé in de eindtijd weer een joodse stad zijn. Het lijkt er allemaal wel op, maar toch zullen wij het toetsen of dat zo is. De 144.000 verzegelden uit Openbaring ziet Pé als de schriftgetrouwen joden die het evangelie wereldwijd uitdragen. Wij zien dat echter niet, aangezien de Israeliërs eerder het evangelie van de haat en uitroeiing van de Palestijnen hanteren. Pé ziet de joden als het ‘heilige en uitverkoren volk’ van God, die in 1948 terug zouden zijn gekeerd naar Palestina. E zevenjarige hongersnood in Egypte tijdens Jozef had voor het joodse volk, zo schrijft Pé het, verrijkende konsekwenties. Pé erkent wel dat het eigenlijk fout is hen joden tenoemen, aangezien ze in die tijd Hebreërs werden genoemd. Maar gemakshalve gebruikt hij toch maar de naam jood. God zou het volk der joden hebben geschapen met het doel om Zijn lof te verkondigen.

Wat is het verschil tussen Israeliet en Jood?

Het is jammergenoeg nog een veelvorkomende zaak onder christenen dat er geen verschil wordt gemaakt tussen joden en Israelieten. U dient zich af te vragen wanneer er in de geschiedenis voor het eerst sprake is van joden. Men kan Abraham geen jood noemen, Izaak en Jakob ook niet, zelfs Juda niet. Elke stam van de 12 zonen van Jakob droeg een eigen naam, en hun nakomelingen werden naar hun stamvader genoemd. Zo is er sprake van Rubennieten, Simeonnieten, Leviëten, Judaïeten, etc. Het volk als geheel werd Israel genoemd, omvattend alle 12 stammen. Het gaat in het begin van de Bijbel meestal over het volk Israel als geheel. Pas na Salomo vond de splitsing plaats en ontstonden de twee huizen:

1. Het Huis Juda, waarbij Benjamin gevoegd was.
2. Het Huis Israels, het 10-stammenrijk.

Het Huis Israels is haar naam kwijtgeraakt, nadat het tijdens drie deportaties in de verstrooiing is gegaan. Zij behoren tot de zogenaamd ‘verloren schapen van het Huis Israels;’. Zij werden weggevoerd naar Assyrië, naar het Noorden. Een deel van het Huis Juda werd meegevoerd en zij vestigden zich in Noord West Europa aan kuststreken.

Het Huis Juda is voor het grootste deel tijdens drie deportaties naar Babel weggevoerd. Een deel daarvan is teruggekeerd onder Ezra en Nehemia, waaronder veel gemengd volk zat. Hier is voor het eerst in de geschiedenis het bijvoeglijk naamwoord ‘jood’ ontstaan, meer als scheldwoord vanwege de edomitische inmenging. Yid of jood wijst eerder naar Edom dan naar Juda. De teruggekeerden bezaten nagenoeg geen stamlijsten en werden yidse Judahieten genoemd, kortweg Yidden of Joden. Men kan en mag dit groepje Yidden niet representatief stellen voor alle joden die naar Palestina trekken. En dát wordt n juist wél gedaan door de meeste christenen in het Weten.

Wij hebben in Nederland 12 provincies. Wij kennen de Zeeuwen, de Hollanders, de Veluwnaren, de Brabanders, de Friezen, etc.

De Friezen, Gelderlanders, etc. zijn we Nederlanders, maar alle Nederlanders zijn geen Friezen, geen Hollanders, Brabanders, Limburgers, etc. Op gelijke wijze kunnen er onder de joden wel Israelieten zitten, maar alle Israelieten zijn geen joden! Wanneer u hierin geen onderscheid maakt, krijgt u een heel vertekend beeld van het Godsplan met Zijn volk. Legacy: A Genetic History of the Jewish People


In his new book, “Legacy: A Genetic History of the Jewish People,” Harry Ostrer, a medical geneticist and professor at Albert Einstein College of Medicine in New York, claims that Jews are different, and the differences are not just skin deep. Jews exhibit, he writes, a distinctive genetic signature. Considering that the Nazis tried to exterminate Jews based on their supposed racial distinctiveness, such a conclusion might be a cause for concern. But Ostrer sees it as central to Jewish identity.

“Who is a Jew?” has been a poignant question for Jews throughout our history. It evokes a complex tapestry of Jewish identity made up of different strains of religious beliefs, cultural practices and blood ties to ancient Palestine and modern Israel. But the question, with its echoes of genetic determinism, also has a dark side.

Geneticists have long been aware that certain diseases, from breast cancer to Tay-Sachs, disproportionately affect Jews. Ostrer, who is also director of genetic and genomic testing at Montefiore Medical Center, goes further, maintaining that Jews are a homogeneous group with all the scientific trappings of what we used to call a “race.”

For most of the 3,000-year history of the Jewish people, the notion of what came to be known as “Jewish exceptionalism” was hardly controversial. Because of our history of inmarriage and cultural isolation, imposed or self-selected, Jews were considered by gentiles (and usually referred to themselves) as a “race.”

Scholars from Josephus to Disraeli proudly proclaimed their membership in “the tribe.”



Ostrer explains how this concept took on special meaning in the 20th century, as genetics emerged as a viable scientific enterprise. Jewish distinctiveness might actually be measurable empirically. In “Legacy,” he first introduces us to Maurice Fishberg, an upwardly mobile Russian-Jewish immigrant to New York at the *fin de siècle*. Fishberg fervently embraced the anthropological fashion of the era, measuring skull sizes to explain why Jews seemed to be afflicted with more diseases than other groups — what he called the “peculiarities of the comparative pathology of the Jews.” It turns out that Fishberg and his contemporary phrenologists were wrong: Skull shape provides limited information about human differences. But his studies ushered in a century of research linking Jews to genetics.

Ostrer divides his book into six chapters representing the various aspects of Jewishness: Looking Jewish, Founders, Genealogies, Tribes, Traits and Identity. Each chapter features a prominent scientist or historical figure who dramatically advanced our understanding of Jewishness. The snippets of biography lighten a dense forest of sometimes-obscure science. The narrative, which consists of a lot of potboiler history, is a slog at times. But for the specialist and anyone touched by the enduring debate over Jewish identity, this book is indispensable.

“Legacy” may cause its readers discomfort. To some Jews, the notion of a genetically related people is an embarrassing remnant of early Zionism that came into vogue at the height of the Western obsession with race, in the late 19th century. Celebrating blood ancestry is divisive, they claim: The authors of “The Bell Curve” were vilified 15 years ago for suggesting that genes play a major role in IQ differences among racial groups.

Furthermore, sociologists and cultural anthropologists, a disproportionate number of whom are Jewish, ridicule the term “race,” claiming there are no meaningful differences between ethnic groups. For Jews, the word still carries the especially odious historical association with Nazism and the Nuremberg Laws. They argue that Judaism has morphed from a tribal cult into a worldwide religion enhanced by thousands of years of cultural traditions.

Is Judaism a people or a religion? Or both? The belief that Jews may be psychologically or physically distinct remains a controversial fixture in the gentile and Jewish consciousness, and Ostrer places himself directly in the line of fire. Yes, he writes, the term “race” carries nefarious associations of inferiority and ranking of people. Anything that marks Jews as essentially different runs the risk of stirring either anti- or philo-Semitism.

But that doesn’t mean we can ignore the factual reality of what he calls the “biological basis of Jewishness” and “Jewish genetics.” Acknowledging the distinctiveness of Jews is “fraught with peril,” but we must grapple with the hard evidence of “human differences” if we seek to understand the new age of genetics.

Although he readily acknowledges the formative role of culture and environment, Ostrer believes that Jewish identity has multiple threads, including DNA. He offers a cogent, scientifically based review of the evidence, which serves as a model of scientific restraint.

“On the one hand, the study of Jewish genetics might be viewed as an elitist effort, promoting a certain genetic view of Jewish superiority,” he writes. “On the other, it might provide fodder for anti-Semitism by providing evidence of a genetic basis for undesirable traits that are present among some Jews. These issues will newly challenge the liberal view that humans are created equal but with genetic liabilities.”

“About 80% of Jewish males and 50% of Jewish females trace their ancestry back to the Middle East”,

Jews, he notes, are one of the most distinctive population groups in the world because of our history of endogamy. Jews — Ashkenazim in particular — are relatively homogeneous despite the fact that they are spread throughout Europe and have since immigrated to the Americas and back to Israel. The Inquisition shattered Sephardi Jewry, leading to far more incidences of intermarriage and to a less distinctive DNA.

In traversing this minefield of the genetics of human differences, Ostrer bolsters his analysis with volumes of genetic data, which are both the book’s greatest strength and its weakness. Two

complementary books on this subject — my own “Abraham’s Children: Race, Identity, and the DNA of the Chosen People” and “Jacob’s Legacy: A Genetic View of Jewish History” by Duke University geneticist David Goldstein, who is well quoted in both “Abraham’s Children” and “Legacy” — are more narrative driven, weaving history and genetics, and are consequently much more congenial reads.

The concept of the “Jewish people” remains controversial. The Law of Return, which establishes the right of Jews to come to Israel, is a central tenet of Zionism and a founding legal principle of the State of Israel. The DNA that tightly links Ashkenazi, Sephardi and Mizrahi, three prominent culturally and geographically distinct Jewish groups, could be used to support Zionist territorial claims — except, as Ostrer points out, some of the same markers can be found in Palestinians, our distant genetic cousins, as well. Palestinians, understandably, want their own right of return.

That disagreement over the meaning of DNA also pits Jewish traditionalists against a particular strain of secular Jewish liberals that has joined with Arabs and many non-Jews to argue for an end to Israel as a Jewish nation. Their hero is Shlomo Sand, an Austrian-born Israeli historian who reignited this complex controversy with the 2008 publication of “The Invention of the Jewish People.”

Sand contends that Zionists who claim an ancestral link to ancient Palestine are manipulating history. But he has taken his thesis from novelist Arthur Koestler’s 1976 book, “The Thirteenth Tribe,” which was part of an attempt by post-World War II Jewish liberals to reconfigure Jews not as a biological group, but as a religious ideology and ethnic identity.

The majority of the Ashkenazi Jewish population, as Koestler, and now Sand, writes, are not the children of Abraham but descendants of pagan Eastern Europeans and Eurasians, concentrated mostly in the ancient Kingdom of Khazaria in what is now Ukraine and Western Russia. The Khazarian nobility converted during the early Middle Ages, when European Jewry was forming.

Although scholars challenged Koestler’s and now Sand’s selective manipulation of the facts — the conversion was almost certainly limited to the tiny ruling class and not to the vast pagan population — the historical record has been just fragmentary enough to titillate determined critics of Israel, who turned both Koestler’s and Sand’s books into roaring best-sellers.

Fortunately, re-creating history now depends not only on pottery shards, flaking manuscripts and faded coins, but on something far less ambiguous: DNA. Ostrer’s book is an impressive counterpoint to the dubious historical methodology of Sand and his admirers. And, as a co-founder of the Jewish HapMap — the study of haplotypes, or blocks of genetic markers, that are common to Jews around the world — he is well positioned to write the definitive response.

In accord with most geneticists, Ostrer firmly rejects the fashionable postmodernist dismissal of the concept of race as genetically naive, opting for a more nuanced perspective.

When the human genome was first mapped a decade ago, Francis Collins, then head of the National Genome Human Research Institute, said: “Americans, regardless of ethnic group, are 99.9% genetically identical.” Added J. Craig Venter, who at the time was chief scientist at the private firm that helped sequenced the genome, Celera Genomics, “Race has no genetic or scientific

basis.” Those declarations appeared to suggest that “race,” or the notion of distinct but overlapping genetic groups, is “meaningless.”

But Collins and Venter have issued clarifications of their much-misrepresented comments. Almost every minority group has faced, at one time or another, being branded as racially inferior based on a superficial understanding of how genes peculiar to its population work. The inclination by politicians, educators and even some scientists to underplay our separateness is certainly understandable. But it’s also misleading. DNA ensures that we differ not only as individuals, but also as groups.

However slight the differences (and geneticists now believe that they are significantly greater than 0.1%), they are defining. That 0.1% contains some 3 million nucleotide pairs in the human genome, and these determine such things as skin or hair color and susceptibility to certain diseases. They contain the map of our family trees back to the first modern humans.

Both the human genome project and disease research rest on the premise of finding distinguishable differences between individuals and often among populations. Scientists have ditched the term “race,” with all its normative baggage, and adopted more neutral terms, such as “population” and “clime,” which have much of the same meaning. Boiled down to its essence, race equates to “region of ancestral origin.”

Ostrer has devoted his career to investigating these extended family trees, which help explain the genetic basis of common and rare disorders. Today, Jews remain identifiable in large measure by the 40 or so diseases we disproportionately carry, the inescapable consequence of inbreeding. He traces the fascinating history of numerous “Jewish diseases,” such as Tay-Sachs,

Gaucher, Niemann-Pick, Mucopolysaccharidose IV, as well as breast and ovarian cancer. Indeed, 10 years ago I was diagnosed as carrying one of the three genetic mutations for breast and ovarian cancer that mark my family and me as indelibly Jewish, prompting me to write “Abraham’s Children.”

Like East Asians, the Amish, Icelanders, Aborigines, the Basque people, African tribes and other groups, Jews have remained isolated for centuries because of geography, religion or cultural practices. It’s stamped on our DNA. As Ostrer explains in fascinating detail, threads of Jewish ancestry link the sizable Jewish communities of North America and Europe to Yemenite and other Middle Eastern Jews who have relocated to Israel, as well as to the black Lemba of southern Africa and to India’s Cochin Jews. But, in a twist, the links include neither the Bene Israel of India nor Ethiopian Jews. Genetic tests show that both groups are converts, contradicting their founding myths.

Why, then, are Jews so different looking, usually sharing the characteristics of the surrounding populations? Think of red-haired Jews, Jews with blue eyes or the black Jews of Africa. Like any cluster — a genetic term Ostrer uses in place of the more inflammatory “race” — Jews throughout history moved around and fooled around, although mixing occurred comparatively infrequently until recent decades. Although there are identifiable gene variations that are common among Jews, we are not a “pure” race. The time machine of our genes may show that most Jews have a shared ancestry that traces back to ancient Palestine but, like all of humanity, Jews are mutts.

About 80% of Jewish males and 50% of Jewish females trace their ancestry back to the Middle East. The rest entered the “Jewish gene pool” through conversion or intermarriage. Those who did intermarry often left the faith in a generation or two, in



FUNDAMENTAL VS FOUNDATIONAL:

The difference between “Fundamental” and “Foundational” can be more easily understood when comparing both within the different two aspects involved in the game of football. The “Fundamental” aspects of football involve such things as “Blocking”, “Tackling”, “Throwing”, “Catching”, “Running”, and “Training”, and so forth. The “Foundational” aspects of football involve such things as individual “Positive Attitude” and “Team-First-Focus”, and collective “Positive Team Morale”. Hence, the “Fundamental” Aspects of football help you become a “participant”, BUT the “Foundational” Aspects of football cause you to become a “winner”. The “participant” learns the “principles”. The “winner” experiences the “principles”, and “passion”! In any case, God’s “Remnant of Israel” experiences and enjoys the latter!

HEBRAIC SCHOOLS OF THOUGHT:

The Hebraic School of “Unitarianism”:

SEVEN STAGES OF THE BIBLICAL HEBREW RELIGION:

1.) AFROCENTRIC, “HEBREWISM”

- From the time of “Adam” and “Eve”, in the Perfect “Garden of Eden” (in “Africa”), until the time of “Noah” and his children; and from the time of “Noah” and his children until the time of “Abraham”.

A.) Hebraic Foundational Stimuli:

1. “The God of Israel” —
The God of Israel Is the, same, God of the Hebrews (Exodus 3:11-15; Exodus 20:3; 2nd Chronicles 6:14; 1st Kings 8:23; Luke 1:68, NIV).

THE TRUE NAME OF THE LORD, WHO “IS” THE TRUE GOD:

“Who but GOD goes up to heaven and comes back down? Who holds the wind in HIS fists? Who wraps up the oceans in HIS cloak? Who has created the whole wide world? What is HIS Name—and his son’s name? Tell me if you know!” (Proverbs 30:4, NIV).

“There he (‘Jacob’) set up an altar and called it El Elohe (Al Alaha/’Almighty God, of’) Israel” (Genesis 33:20, NIV).

“Moses said to God, Suppose I go to the Israelites and say to them, ‘The God of your fathers has sent me to you,’ and they ask me, ‘What is His Name?’ Then what shall I tell them? God Said to Moses, ‘I AM, WHO (I) AM (YAH, UW-AH). This is what you are to say to the Israelites: I AM (YAH) Has Sent me to you.’ God also Said to Moses, ‘say to the Israelites, The LORD (YAHUWAH), the God of your fathers—the God of Abraham, the God of Isaac and the God of Jacob—Has Sent me to you. This is My Name (YAHUWAH) forever, the Name (YAHUWAH) you shall call Me (forever) from generation to generation” (Exodus 3:13-15, NIV).

“And I appeared unto Abraham, unto Isaac, and unto Jacob, by the name of God Almighty (El Elohe/Al Alaha), but by My Name JEHOVAH (YAHUWAH) was I not known to them” (Exodus 6:3, KJV).

“But for the sake of My Name (YAHUWAH), I brought them out of Egypt. I did it to keep My Name (YAHUWAH) from being profaned (perverted/misinterpreted) in the eyes of the nations (heathens) among whom they lived and in whose sight I had Revealed Myself to the Israelites” (Ezekiel 20:9).

“I will make known My Holy Name among My people Israel. I will no longer let my Holy Name be profaned

(perverted/misinterpreted), and the nations will know that I the LORD (YAHUWAH) am the Holy One in Israel” (Ezekiel 39:7, NIV).

“I will show the Holiness of My Great Name, which has been profaned (perverted/misinterpreted) among the nations, the Name you have profaned (perverted/misinterpreted) among them. Then the nations will know that I am the LORD (YAHUWAH), declares the Sovereign LORD (YAHUWAH), when I AM proved Holy through you before their eyes” (Ezekiel 36:23).

“You shall not misuse (pervert/distort/misinterpret) the Name of the LORD your God (Al-i YAHUWAH), for the LORD (YAHUWAH) will not hold anyone guiltless who misuses His Name” (Exodus 20:7, NIV).

“Anyone who blasphemes (defames/profanes/pollutes/perverts/misuses/misinterprets) the Name of the LORD (YAHUWAH) is to be put to death. The entire Assembly (Ecclesia/Congregation of Christ) must stone them. Whether foreigner or native-born, when they blaspheme (profane/pervert/misinterpret) the Name (YAHUWAH) they are to be put to death” (Leviticus 24:16, NIV).

“As it is written: God’s Name (YAHUWAH) is blasphemed (defamed) among the Gentiles because of you, just as it is written” (Romans 2:24, NASB).

[[In Romans 2:24, Apostle Saul (“Paul”) was speaking to the Edomite Priests that, were not teaching, and were not practicing, God’s Everlasting “Moral Law” correctly. The Edomite Priests became adherents to, and leaders of, either “Pharisee Judaism” or “Sadducee Judaism”. And, some Edomite Priests became members of the “Sanhedrin”, BUT they were NOT Israelite

Priests, because they descended from “Esau”. Hence, they were NOT Israelites who descended from “Jacob”. Therefore, the Edomite Priests were NOT “Jews” (Revelation 2:9; Revelation 3:9). On the other hand, the Christ and his True Disciples were truly the descendants of “Jacob” and, therefore, were “Jews” from the True Israelite Heritage. Hence, the Christ and his True Disciples and Apostles became adherents to, and leaders of, “Nazarene Judaism”, BUT NOT members of the “Sanhedrin”. The main reason why the Christ spoke sternly toward the Edomite Priests was, because the Edomite Priests were NOT interested in “the justice, mercy and faith of God” or “the love for the True Israelite Peoples”, rather, the Edomite Priests were interested in “the love of money” and “the lust for power” (Matthew 23:1-38, NASB). I am very surprised at how some pseudo-followers of the Christ — who obey, and teach the importance of, the Fourth, Fifth, Sixth, Seventh, Eighth, Ninth, or Tenth, Commandment of God — choose to, blatantly disobey, and not teach the importance of, the First, Second, or Third, Commandment of God. If someone were to call someone else by a wrong name other than the one they’ve told others to specifically use, then the one being called by that wrong name will “correct” the one who calls them by the wrong name, and eventually if the wrong name caller continues to “misuse” their name, then, eventually they will “ignore” the person who’s “misusing” their name, because it’s NOT the name they’ve told others to specifically call them by. There is a BIG difference between using a “Title” such as “God” (Creator of the Universe) or “LORD” (RULER of the Universe), and calling upon, or praying in, or praising, the “Name” of The Person Who Is the Creator, and the RULER, of the Universe. For example, I am “expected” to address a “Doctor” by his/her “Title” — “Doctor” — but they would NEVER allow me to use a different “name” other than the “name” they’ve specifically told me to use such as Robert Thomas/Roberta Thomas; otherwise my choice to “misuse” their “name” would cause them to correct me

and eventually ignore me; and if I were to continue “misusing” their “name”, by using another name such as Wilhelm Fredrick/Wilhelmina Fredrick which is different than their specific “name” Robert Thomas/Roberta Thomas (especially on a “legal document”) then, they could charge me according to the “Criminal Law” of the country i reside in. How much MORE SO does YAHUWAH “Expect” me to call HIM by HIS “Name” YAHUWAH, the “Name” HE Has Commanded me to call HIM by (Exodus 6:3; Psalm 105:1), which I CANNOT disobey, or HE Will Charge me according to HIS Everlasting “Moral Law” and if I don’t repent HE Will Disallow me entry into His Everlasting “Messianic Kingdom” (1st Kings 2:3, KJV). Therefore, the “Name” of YAHUWAH Is one of the “Signs” in Heaven HE Displays in Earth. The other “Signs” in Heaven that YAHUWAH Displays in Earth, as in Heaven, involve HIS “Christ” of Righteousness and HIS “Commandments” of Righteousness, including the Nine “Signs” in the Everlasting Sabbaths of HIS Holy Appointed Times (Leviticus 23:1-44; John 10:22). This is, PRECISELY, why I have made the life-long choice to “Repent”, of the false beliefs and false teachings of the Imperialist Churches of Gentile Christianity, and “Believe” in the “True Gospel” of the True “Kingdom of God”, from its Original ANCIENT HEBREW PERSPECTIVE within its Original Jewish Historical Context from which it was first written and taught (Mark 1:15; John 4:7-9; John 4:22-23; Jeremiah 10:2, NKJV).]]

“Blessed be the Name of the LORD (YAHUWAH) from this time forth and forevermore” (Psalm 113:2, ESV).

“Praise the LORD! Praise the Name of the LORD (YAHUWAH), give praise, O servants of the LORD” (Psalm 135:1, ESV).

“Let them praise the Name of the LORD, for HIS Name (YAHUWAH) Alone Is Exalted; HIS Majesty Is Above death AND heaven” (Psalm 148:13, ESV).

“I will take away the names of the Baals (False gods) from her (‘the Church’s and/or ‘the Synagogue’s) mouth, and they (the pagan names of the false gods) will not be mentioned by My Name (YAHUWAH) anymore” (Hosea 2:17).

“Pray like this: Our Father (Ab-ba) in heaven, may Your Name (Al Alaha YAHUWAH/’The LORD God Almighty’) be kept Holy” (Matthew 6:9, NLT).

“I have come in my Father’s name (and my name is Yahuwah-sha/’salvation of YAHUWAH/’salvation of the LORD’), and you do not accept me; but if someone else comes in his own name, you will accept him” (John 5:43, NIV).

“For I say to you, from now on you will not see me until you say, Blessed is he (‘Mash-yah/’Messiah/’Christ’) who (with his new name Yahuwah-zadak/’righteousness of the LORD’) comes in the Name of The LORD (YAHUWAH)” (Matthew 23:39, NASB – Reference: Revelation 3:12, NASB).

Therefore, as you can CLEARLY SEE, in the aforementioned sacred scriptures of the “Bible”, that blaspheming, perverting, polluting, defaming, misusing and/or misinterpreting the Holy Name of “YAHUWAH” (the “LORD”/”RULER”) of the Universe, Who Is “Al Alaha” (the “God Almighty”/”Creator”) of the Universe, is a VERY SERIOUS OFENSE according to “AB-ba” (“our FATHER”) WHO IS “SHAPHAT” (the Original “JUDGE”) of the Universe! Likewise, you can CLEARLY SEE, in the “Bible”, that “the Christ” (“Yahuwah-sha”/”Yahuwah-

zadak”) is the created first-born “son” of the LORD God Almighty!

The Ancient Hebrew “Tetramagratton” consists of four Ancient Hebrew Letters, which are four consonants, that display the Ancient Hebrew Name of “The LORD” as “H W H Y” (also known as “The RULER/MASTER of the Universe” — notice how the Ancient Hebrew Letters were written/scribed from the right side, to the left side, of each page).

The Ancient Hebrew Language did NOT have any vowels, and it did NOT have a letter “J”. The Audible sounds between these four consonants of the Ancient Hebrew “Tetramagratton” sounded as “awe” where the letter “a” has since been inserted, and “uwh” where the letter “u” has since been inserted, in order for the True Name of “The LORD” to be pronounced as close to Its Original Sound as humanly possible.

These four letters/consonants of the “Tetramagratton” have been discovered on Ancient Hebrew Parchments of the “Dead Sea Scrolls” that, were unburied in the Land of Israel, and are reliable historical-biblical artifacts.

The following picture displays the four consonants of the “Tetramagratton” — the True Name of The “LORD” (H W H Y = Y H W H = Y a H u W a H), The “God of Israel” — in the Ancient Hebrew Language, which was discovered in the Land of Israel.

Once again, the four consonants of the True Name of “The LORD”, written as the “Tetramagratton”, are “H W H Y”; and because Ancient Hebrew words are written from the right side, to the left side, of each page they are sounded as they are written from the right side, to the left side, of each page. Hence, we will often see the letters “Y H W H” written in Modern English whenever the True Name of “The LORD” Is transliterated from

Ancient Hebrew to Modern English for the sake of easier recognition, and pronunciation for English speaking Peoples. In fact, the letter “Y” in Ancient Hebrew represents the letter/word “I” in Modern English (and in some cases the letter “Y” can also represent the word “my”, or “me”, or “Is” particularly when “Y” is at the end of an Ancient Hebrew Word); and the letter “H” in Ancient Hebrew represents the word “AM” in Modern English; and the letter “W” in Ancient Hebrew represents the word “THAT” in Modern English; and the letter ‘H’ as previously mentioned represents the word “AM”. Hence, The Great “I AM THAT AM” (aka, “I AM WHO IS”) Who Revealed His True Name to “Moses” in the Book of Exodus in the “Bible”, will always “BE” The True Name of “The LORD”. Therefore, the “Hallowed Name”/“Holy Name” of “our Father”/“the Father” whom the Christ/Messiah says we MUST pray TO and worship ONLY Is “YaHuWaH”, or “Yah-uw-ah” in Ancient Hebrew, which when translated to Modern English is “LORD”, or “Lord”. Hence, the biblical term “The LORD” or “The Lord”, is “Ha-YaHuWaH”, or Ha-Yahuwah”, whereby the English word “The” is “Ha” in ancient Hebrew (Matthew 6:9-10; John 4:22-23, KJV). Likewise, the True Name of “GOD” (“Creator of the Universe”) in the Ancient Hebrew Language Is “AL”, which was written as “El” in the Ancient Babylonian Chaldean Language. Therefore, “Al YAHUWAH” (or “AL Yah-uw-ah”) Is the Acceptable True Holy Name of the “LORD God”, which was the “God of the Hebrews”, and the “God of Abraham, and of Isaac and of Jacob” and the “God of Israel”. Have you ever asked yourself, honestly and intelligently, “Why is the Name of our Heavenly ‘Father’ not in the ‘New Testament’ portion of the ‘Bible’, and what is His Hallowed/Holy Name?”. In the “Old Testament” portion of the “Bible” (KJV) the Hallowed/Holy Name of our Heavenly Father is written in the Modern English Language as “JEHOVAH” (“LORD”) and in the Ancient Babylonian Chaldean Language as “El-elohe” (“God Almighty”) as referenced in Exodus 6:3, and

Genesis 33:20, respectively. The True Hebrew Holy Name of our Heavenly Father, as it was spoken by the Christ in prayer, was “Al Ab-ba YAHUWAH” (“The LORD, our Father, God”). The reason why the Hebrew Holy Name of our Heavenly Father was taken out of all Gentile Versions of the “Bible” was because of the Anti Hebrew, and Anti-Semitic, racism that some European Gentile Christian Church Leaders in many European Gentile Christian Churches have taught and practiced (overtly or covertly) from the days of the Ancient Roman Empire to these present days. We are Commanded by the “LORD” in the “Bible” to “say” HIS True Hebrew Holy Name, “Al YAHUWAH” (“LORD God”), or “AL Yah-uw-ah” (“Lord GOD”), in praises and songs and prayers unto “HIM” as in Psalm 68:4, Psalm 113:2, Psalm 135:1 and Psalm 148:14. Interestingly, the true name of the true Christ/Messiah has the Name of the “LORD”, “YAH-UW-AH”, in his name, as “Yah-uw-ah-sha” (transliterated as “Josh’-u-a”, but certainly NOT “Je-sus”); and “Yah-uw-ah-sha” (or “Yah-sha”) means “salvation of The LORD”. Hence, the Hebrew Word “sha” represents the English Word “salvation”, and the Hebrew Word “Yah-uw-ah” (or “Yah”) represents the English Word “LORD”. However, the Christ/Messiah is NEITHER the “LORD, God of the Hebrews” NOR the “LORD, God of Israel”; and the Christ is NEITHER equal to the “LORD, God of the Hebrews” NOR the “LORD, God of Israel”. The Christ/Messiah is NOT “God” (aka, “GOD”)! The Christ/Messiah has been “Created”, and “Appointed”, and “Anointed” and “Sent” by “God” (“GOD”) in order for “God” to, Ordain the Christ as the “Priest” and “Suffering Messiah” of Israel during the Christ’s First Advent, and Coronate the Christ as the “King” and “Conquering Messiah” of Israel during the Christ’s Second Advent, when the Christ Returns to Rule the Reunited, Restored, “Kingdom of Israel” for 1,000 Years on EARTH. This is why he was called “Christ” (or “Messiah”), and “King of the Jews” and “King of Israel” in the “New Testament” portion of the “Bible” (Matthew 16:16;

Matthew 27:37; Mark 15:2; John 1:49; John 4:25-29. The word “King” is “Adahn” in Ancient Hebrew, and “Adon” in Ancient Babylonian Chaldean. Hence, the Ancient Hebrew word “Adahn-i-YAH” (aka, “Adonai”/”Adoniah”) is “The LORD my KING/MASTER”, of the Universe, in Modern English. The word “Messiah” in Ancient Hebrew is “Mash-Yah”, which means “The Lord’s Anointed”, or “the Christ” in Modern English. Therefore, he (“the son of God”) MUST NEVER be called “The Lord”, or “The LORD”, because the ONLY “Lord”, or “LORD”, is his Father Yah-uw-ah! Hence, ONLY his Father “Yah-uw-ah” can be referred to by the Title “Adahn-i-Yah” or “Adonai”/”Adoniah”) — “The LORD my KING/MASTER”! Hence, The Father, “Yah-uw-ah”, Is the “King of the Entire Universe” Who Has “Created”, and “Appointed”, and “Anointed” and “Sent” the Christ/Messiah to be ONLY the “King of Israel” for ONLY a 1,000-Year Period on Earth, at the end of which the Christ/Messiah MUST give God’s Kingdom back up to “The LORD”, his Father, “Ab-Yah-uw-ah”. Therefore, YAHUWAH Is the “Name” of the ONLY RULER AND CREATOR of the Universe, but YAHUWAH Has some “Titles” HE “Allows” us to refer to HIM by, such as “GOD” or “God” (“Creator of the Universe”), and “LORD” or “Lord” (“Ruler of the Universe” or “Judge of the Universe”), and “Saviour”, and “Redeemer”, and “Father” or “Husband”, etc. Those are the “Titles” that, belong ONLY to YAHUWAH, and YAHUWAH “Allows” us to refer to HIM by! Hence, the Christ/Messiah only came to Israel “in” the Name of “The LORD”, his Father, and thus had the Name “Yah-uw-ah” in his name which was “Yah-uw-ah-sha” — “salvation of/from YAHUWAH” — the first born “son of God”. Therefore, you MUST NEVER pray to or worship or praise the name of the son, “Yah-uw-ah-sha” (certainly NOT the name of “Je-sus”) — instead you MUST ALWAYS AND ONLY pray to and worship and praise YAHUWAH, which Is “The Name” (“Ha-Shem”) of The Father, “The LORD”! Let’s NOT forget that, the “Title” of

the Anti Christ in Ancient Hebrew was Ab-adahn (“Abaddon”), which means “Master Father”, which is the “Title” that the Edomite Priests and the Catholic Popes desired/desire to be called by (“Apollyon” is the “Title” of the Anti Christ in the Greek Language). This is, exactly, why the Christ/Messiah warned his true followers to, ONLY refer to YAHUWAH As our ONLY “Master” and ONLY “Father”, and NEVER refer to any other person as our “Master” or “Great One” (aka, “Rabbi” or “Good One”) or “Father”, because YAHUWAH Is our ONLY “Father” and our ONLY “Master” and our ONLY “Great One” and our ONLY “Good One” THAT “Dwells” in the MOST HIGH HEAVEN, Whose “Name” is YAHUWAH. Furthermore, the biblical term “The LORD our God” is “Al-ba YAHUWAH” in Ancient Hebrew, which is read and pronounced from the right side, to the left side, of the page. In addition, the biblical term “LORD God” is “Al YAHUWAH” in Ancient Hebrew; and the biblical term “Lord GOD” is “AL Yahuwah” in Ancient Hebrew. Hence, the biblical term “The LORD, God of Israel” is “Y’sra’al ah Al, YAHUWAH” in Ancient Hebrew. Also, the biblical term “God” is “Al” in Ancient Hebrew, and the biblical term “our God” in Ancient Hebrew is “Al-ba”, and the biblical term “our Father” is “Ab-ba” in Ancient Hebrew, and the biblical term “GOD” is “AL” in Ancient Hebrew. Some of the other Hebrew Titles of The True God in the “Bible” include “Al Alyahn” (“Most High God”), and “Al Alam” (“Everlasting God”), and “Al Annara” (“Awesome God”), and “Al Ahad” (“One God”), and “Al Hann’aman” (“Faithful God”), and “Al Shadda’y” (“my All Sufficient God”), and “Al-ah Amat” (“Truth of God”), and “Al-ah Zadak” (“Righteousness/Justice of God”), and “Al Kanna” (“Jealous God”), and “Al’y Ha-Yahuwah” (“The Lord, is God”). Hence, the Hebrew name “Aliyahu, Bin Abruaham” is “Elijah, Ben Abraham”, or “Elijah, son of Abraham”, in Modern Hebrew and Modern English, respectively. Often, “Al”, “God”, is referred to as “Alahym” in Ancient Hebrew (“Elohim” in Ancient

Babylonian Chaldean), only, for the sake of the “Remnant of Israel” to have the understanding of the “Divine Unity” of the “Family of God” for the “Remnant of Israel” who are of the “First Resurrection” when the Christ/Messiah Returns to EARTH. Moreover, the biblical term “God Almighty” should be “Almighty God”, which is read from the right to the left in Ancient Hebrew and therefore is “Al Alaha” in Ancient Hebrew. Hence, the biblical term “Almighty God of Israel” is “Y’sra’al ah Al Alaha” in the Ancient Hebrew Language, and “El-elohe Israel” in the Ancient Babylonian Chaldean Language. YAHUWAH, The Father, God, Is A “Jealous God” Who Desires all of our undivided attention in our worship to HIM. YAHUWAH, The Father, God, NEVER allows anyone to divide their attention in worship among three persons or two persons whom the Gentiles claim are, supposedly, the Creator of the Universe! Therefore, God Has NO coequal person, or persons (Exodus 20:5; Exodus 34:14; Deuteronomy 4:24; Deuteronomy 6:15; Isaiah 40:25). Hence, the “God Almighty, of Israel” Is The Father, God, of (and Above and Greater than) the Christ/Messiah and the “saved” (Genesis 33:20; Exodus 6:2-3; John 4:22-23; John 20:17; Romans 15:6; 1st Corinthians 15:20-28; 2nd Corinthians 1:3; 2nd Corinthians 11:31; Ephesians 1:17; Ephesians 4:6; 1st Timothy 2:5; Revelation 1:6; Revelation 3:12; Revelation 20:1-15, KJV).

Father God “IS” Before all, and Above all, in all the Universe!

- The Holy Hebrew Name of The “Father”, of all the Universe, “IS” YHWH, or Yahuwah, or AL Yahuwah (all singular) in the Ancient Hebrew Language.
- Ab’ba Yahuwah = “The LORD, our Father” (Matthew 6:9-10, KJV)
- Ishi’y Yahuwah = “The LORD, my Husband” (Hosea 2:16-23, KJV) — the “Remnant of Israel”, of this present 6,000-Year Age, are “betrothed/engaged to be married” to Yahuwah, Y’ishi until the beginning of the 1,000-Year Reign of the Christ/Messiah, at

which time Yahuwah, Y'ishi will “Wed” the Christ/Messiah, and the Chosen Ones, whom Yahuwah “Gathers”, that have remained Faithful in the “Remnant of Israel” which the Christ/Messiah will “Assemble”, and immediately following this “Wedding Marriage” will be the “Wedding Feast” that takes place after the “Battle of Armageddon” (Revelation 19:9-21. KJV).

- Al YAHUWAH, aka, “El JEHOVAH” = “LORD God” (singular).
- YAHUWAH “IS”, and YAHUWAH Will ALWAYS “BE”, THE ONE, AND ONLY, “LORD” (RULER) of all the Universe!
- YAHUWAH “IS”, and YAHUWAH Will ALWAYS “BE”, THE ONE, AND ONLY, “GOD” (Creator) of all the Universe!
- The “Father”, of all the Universe, “IS” The One True God (singular) = “Al” (aka, “El”, in the Ancient Babylonian Chaldean Language).
- The “Father”, of all the Universe, Is “Aluhiym” / “Elohiym” (plural), because The “Father”, of all the Universe, Is Able to Have HIS “sons” (and “daughters”) living in HIM, as HE lives in them.
- The “Father”, of all the Universe, “IS” The “Almighty God” (singular) = “Al Alaha” (“El-elohe”, in the Babylonian Chaldean Language).
- The “Father”, of all the Universe, “IS” The “Most High God” (singular) = “Al Alyahn” (aka, “El Elyon”, in the Ancient Babylonian Chaldean Language).
- The “Father”, of all the Universe, “IS”, Always, All Loving, All Knowing, All Powerful, and All Good. HE CAN'T be Loving one minute and Unloving the next. HE CANNOT be Partially WHO HE Says HE ALWAYS “IS”! HE Says that HE IS NOT 3 person, or 2 persons!
- The “Father”, of all the Universe Has, NO co-equals!
- The “Father”, of all the Universe, Has Desired and Designed a Divine Plan to “Manifest”, and “Multiply”, HIS OWN ONE SELF through, every angel being, and every human being, but

they are NOT equal to HIM, and shall NEVER be equal to HIM!

- The “Father”, of all the Universe, Has HIS Divine Power, and HIS Divine Nature, In HIS “Holy Spirit” (HIS Righteous, Holy Spirit-Soul).
- The “Father”, of all the Universe, Is ALWAYS “One God in billions of other persons who are in Him”!

2. “The Messiah of Israel” —

A man who is a direct descendant of “Jacob” that came from one of “Jacob’s” Original Twelve Tribes of Israel, which is the Original Israelite Hebrew Tribe of “Judah” (Matthew 1:1-16; Luke 3:31-38; Acts 13:38; 1st Timothy 2:5, KJV).

The “Bible” shows who the ‘Messiah’ of God’s Kingdom is, in Earth.

“My Kingdom is NOT of this (material) world: if my Kingdom were of this (material) world, then would my servants (‘students’) fight, that I should not be delivered to the Jews (who were leaders of the Sanhedrin): but now is my Kingdom not from hence. Pilate therefore said unto him, Art thou a King then? Jesus answered, Thou sayest that I am a King. To this end (future Manifestation) was I born, and for this cause came I into the world, that I should bear witness unto the (Tenable) Truth. Every one (every human) that is of the (Tenable) Truth heareth (me through) my voice” (John 18:36-37).

“But thou, Bethlehem Ephratah, though thou be little among the thousands of Judah (direct descendants of ‘Judah’, a son of ‘Jacob’), yet out of thee shall he (Messiah/Christ) come forth unto Me that is to be Ruler (‘King’) in ‘Israel’; whose goings forth have been from of old (as the ‘Angel of the LORD’/‘Angel of

God'), from everlasting" (Micah 5:2).

Cross Reference: John 19:12-22.

An "Advocate" of God's Kingdom was living on Earth among the Peoples of "Israel", nearly 2,000 years ago, in the person of Messiah-Christ during his "First Advent", but he will be the "King" of the future, "Kingdom of Israel", in Earth, which will be a Replication of God's Heavenly Kingdom, in Earth, during his soon-coming "Second Advent".

The Kingdom of God is within the spirit of each and every human being and will be Manifested by God through the spirit of those who, collectively, learn how to, submit to the One True God, and allow the One True God to Manifest His Kingdom through us, into all the Earth, with His Divine Unity (Luke 17:20-23, KJV).

God's Kingdom is NOT going to Manifest in Earth by our observation.

God's Kingdom will Manifest in Earth by our choices to, seek, find and embrace the Eight-fold Structure of God's Kingdom and the Two-fold Status of God's Righteousness, in Earth, and "let go and let God" Do the "Cleansing" of the "negative blockages" in us that block the Manifestation of the One True God's Kingdom, in Earth, as it is in Heaven.

Messiah/Christ came to Earth during his "First Advent" in order to show us the "Way" of God's Righteousness, which is to "Practice" living as if already in God's Kingdom in Earth, before God's Kingdom is Manifested in Earth, when the Messiah/Christ Returns.

Messiah/Christ came to Earth as a human during his "First Advent" in order to, be the atoning blood sacrifice for all the wrongs of all humans, and obtain the right to be the future, "King of Israel" within the future "Kingdom of God" on Earth, during his "Second Advent", as God's Messiah-Christ for all humankind — especially the "Remnant of God".

Messiah/Christ is Returning to Earth in order to "Restore" the Old, "Kingdom of Israel" into the New, "Kingdom of Israel", which is the "Righteous Replication" of the Kingdom of God in Heaven, as the Kingdom of God in Earth, as if it were in Heaven (Matthew 6:10; Acts 1:6).

Messiah/Christ did NOT start or lead a "Religious Organization"! He started and led a "Group" of Peoples that were "Students" (aka, "Disciples"), and "Practitioners" (aka, "Teachers"/"Therapists" of Natural Healing), and "Ministers" (or, "Preachers", aka, "Seminar Presenters" of this Gospel of the Kingdom of God) who travelled from village to village and/or from city to city and/or from country to country! Their "Faith" was "Nazarene Unitarian Judaism", which evolved into the "Jewish Unitarian Christianity" of the "Nazarenes", between the 1st Century AD/CE and the 4th Century AD/CE.

The word "Messiah" in the Ancient Hebrew Language is "Mash-yah", which means "the LORD'S Anointed" (aka, "Anointed of the LORD") and refers to those called by the God of Israel to be a "Servant of the LORD".

There have been many "Servants of the LORD" who have been "Anointed" by the LORD (YAHUWAH) with HIS "Holy Fire" for the sake of "Serving the LORD", in the "Work of the LORD", in the capacities of "Prophets", "Priests", "Judges", or "Kings". However, there is ONLY one person that has been "Anointed" by the LORD (YAHUWAH) who, was the "Angel of the LORD" (Exodus 3:2; 23:20-21) in the "Old Testament" times, and was the "Messiah of the LORD" (Matthew 1:21) in the "New Testament" times. That person was "Yahuwah-sha ha Mash-yah" (aka, "Jesus the Christ"). He was "Created", and "Anointed" by the LORD in order to do the "Work of the LORD", in the capacity of a "Deliverer" as an Angel Being in the "Old Testament" times, and in the capacity of a "Prophet" and "Priest" as a human being in the "New Testament" times, and in the

capacity of a “Deliverer”, and a “Prophet”, and a “Priest”, and a “Judge”, and a “King”, when he Returns, soon, in order to, Restore the “Kingdom of Israel”, and Re-Establish the Kingdom of God, in Earth, and Receive his Royal Crown as “King of Israel” (aka, “King of the Jews”) for 1,000 Years!

Father God’s first-created, and first-born, son “is” a created “god” who’s lesser than, and NOT equal to, Father God!

- Yah-uw-ah-sha = “salvation of/from The LORD”.
- Yah-uw-ah-sha is an “al” (aka, “god” – “created mighty god” – “el”, in the Ancient Babylonian Chaldean Language).
- Yah-uw-ah-sha, aka, “Jes-us”, has a Full Portion of Father God’s “Holy Spirit” (Divine Power, and Divine Nature) in him. In this “Way”, he has become the fullness of Father God, but Yah-uw-ah-sha is NOT Father God, and Yah-uw-ah-sha is NOT equal to, and NOT co-equal to, Father God.
- Yah-uw-ah-sha was Sent to Earth as an Angel Being called “Angel Amanual” (aka, “Angel Immanuel/Emanuel”, or “Angel of the LORD”) in the “Old Testament”.
- Yah-uw-ah-sha was Sent again to Earth, later, as a very humble human being called Amanu-al” (aka, “Immanuel/Emanuel”) in the “New Testament”.
- Yah-uw-ah-sha was a Jewish-Israelite, Hebrew Prophet-Priest.
- Yah-uw-ah-sha learned, obeyed, and taught the Righteous and Everlasting “Moral Law”, which is found in the Jewish-Israelite Torah (“First Five Books of the Bible”); and Yah-uw-ah-sha commanded all his disciples (students/followers) to learn, obey and teach the Righteous and Everlasting “Moral Law”, which is found in the Jewish-Israelite “Tah-arah” (aka, “Torah”).
- Yah-uw-ah-sha observed, and obeyed, all of God’s Holy Appointed Times (“Sabbath Days, Sabbath Feasts and New Moons”), and God’s Holy Appointed Foods (“Clean Foods”), and God’s Holy Appointed Relationships (“Righteous Relations”); and Yah-uw-ah-sha commanded all his disciples

(students/followers) to observe, and obey, all of God’s Holy Appointed Times, and Holy Appointed Foods, and Holy Appointed Relationships!

- Yah-uw-ah-sha was a Jewish-Israelite Man from the Jewish-Israelite Tribe of “Judah”.
- Yah-uw-ah-sha had Arabian-Semitic, and Asian-Hamitic, and African-Hamitic bloodlines in his Biblical-Biological Lineage, which would cause him to be identified and classified as a “black Man”, aka “black Messiah”, by today’s European Gentile “ethnic classification”.
- Yah-uw-ah-sha (aka, “Je-sus”) was a “black Man”, a “Black Messiah”, sent to Israel by the God of Israel.
- Yah-uw-ah-sha died for all the sins and iniquities of all peoples of all colours, and all nations!
- Yah-uw-ah-sha, after his ascension up into the Heavens, allowed his holy, “Spirit” (of Truth and Grace) to be “poured out” (available) to all peoples of all colours, of all nations!
- Yah-uw-ah-sha will be Sent again to Earth as a Mighty Angelic Being called “Zadak-Ha-Yah” (“Zedekiah”, “The LORD’S Righteousness/Justice”) when he Returns to Earth in order to, 1, Defeat all the enemies of the True “God” (YAHUWAH), 2, Restore the future Jewish-Israelite “Kingdom of Israel” on EARTH, and 3, Reestablish the future “Kingdom of God” in the Jewish-Israelite Restored “Kingdom of Israel” on EARTH, and 4, Redeem the Remnant of “Israel” (some Israelites, and some Jews, and some Gentiles, in the future First Resurrection) who, have continued in their “faith” of allegiance to the Christ of Righteousness, AND have continued in their “works” of obedience to the Commandments of Righteousness (Isaiah 51:1-6; Revelation 12:17; 14:12, KJV).



Yahuwah-sha was Sent to the “Remnant of Israel” during the 1st Century AD/CE., as a “Humble Lamb”, but he will Return to the “Remnant of Israel” soon, as a “Mighty Lion”!

Yahuwah-sha was a “black Man” — “black Messiah” — who, was a direct descendant of the black-skinned Peoples from “Ham’s” Lineage, and was also a direct descendant of the brown-skinned Peoples from “Shem’s” Lineage, BUT Yahuwah-sha loves all Peoples of all Nations!

3. “The Identity of Israel” — A person who is a descendant of “Jacob” that is “grafted back into” the “Remnant of Israel”, or one who is a “Gentile” that is “grafted into” the “Remnant of Israel” (Exodus 1:1-2; Romans 11:1-27).

The “Bible” shows us who the ‘Remnant’ of God’s Kingdom is, in Earth.

“And except those days should be shortened, there should no flesh be saved: but for the elect’s (the direct descendants of the True, Twelve Tribes of Israel’s) sake those days shall be shortened. Then if any man shall say unto you, Lo, here is Christ (Messiah), or there; believe it not. For there shall rise false prophets, and shall shew great signs and wonders; insomuch that, IF it were possible, they shall deceive the very elect” (Matthew 24:22-24).

“And the LORD shall bring thee into Egypt (Africa) again with ships (escaping the Pagan Gentile Roman Empire’s Destruction of Jerusalem), by the way (into West Africa) whereof I spake unto thee, Thou shalt see it no more again: and there (West Africa) ye shall be sold unto your (Gentile) enemies (via the Trans Atlantic Slave Trade) for bondmen and bondwomen, and no man shall buy (pay wages to) you” (Deuteronomy 28:68, KJV).

“And the LORD shall scatter thee among all people, from the one end of the Earth (North America, Central America, South America, and Caribbean Islands) even unto the other (West Africa, South Africa, North Africa, East Africa, Arabia, Europe, Eurasia, South Asia, Central Asia, East Asia, Southeast Asia, and the South Pacific); and there thou shalt serve other gods (other than the “God of the Hebrews”, and instead a “Christian wooden cross” and “Islamic meteorite rock”), which neither thou nor thy (fore) fathers have known, even wood and stone” (Deuteronomy 28:64, KJV).

According to the Ancient Hebrew Scriptures, the Peoples who were direct descendants of “Jacob” were called “the children of Israel” (aka, “Israelites”), but the Peoples who were direct descendants of “Japheth” were called “Gentiles” (Genesis 10:1-5; Genesis 29:1-35; Exodus 9:4; 17:1; Numbers 21:10; Deuteronomy 10:6; Joshua 9:17). Eventually, Gentiles began referring to the “Israelite” Peoples as “Jews”, because the “Israelite” Peoples were living in the Canaanite Land called “Yudi”, which the Gentiles called “Judi”, and, later, called “Judea”. Hence, the Gentile word “Jew” stems from the Gentile word “Judea”.

Therefore, the “Original Jews” have, correctly, been identified and understood as “a person who, is a direct descendant of ‘Jacob’, and has descended (biologically/genetically) from one or more of the True, Twelve Tribes of Israel”. Hence, the “Original

Jews” who have descended (biologically/genetically) from “Jacob” are the “elect”, “saints”, “Remnant of Israel”, or “Remnant of God”, or “God’s Chosen Ones”, who are “direct descendants of Jacob” (Ephesians 2:11-13; 3:1-19). Hence, the Ancient Hebrew Scriptures clearly identify the Peoples who were direct descendants of “Esau” as “Edomites” (aka, “Semitic-Gentiles”) who, were NEVER, and are NOT, descendants of “Jacob” (Genesis 25:21-27; Genesis 36: 1-43; Deuteronomy 23:7; 1 Samuel 21:7; 1 Kings 11:14-25; Matthew 2:1-20).

The “Bible” clearly shows us that “Gentiles” CANNOT EVER become “the elect”, or “the saints” in and of themselves. The “Gentiles” who have converted to a form of “Judaism” are called “Proselytes”, because they are NOT descendants of “Jacob”. The descendants of “Jacob” are the “saints”, or “elect” in the “Bible” (Acts 2:10; 6:5; 13:43; Romans 1:16; 1 Corinthians 16:1-3, 15-16; Deuteronomy 33:1-29). The “Gentiles” are called “Proselytes”, because they are NOT descendants of “Jacob”. The descendants of “Jacob” are the “saints”, or “elect” in the “Bible” (Acts 2:10; 6:5; 13:43; Romans 1:16; 1 Corinthians 16:1-3, 15-16; Deuteronomy 33:1-29). Every “Gentile”, in the “Bible”, is a “Proselyte” (“Non-Israelite”/“Non-Jew”) who MUST have their mindset/belief system “Converted” with the True Teachings of the True Messiah/Christ that he taught from a “Jewish” Hebrew Perspective. Hence, every Gentile MUST be “adopted” into the extended family of “Jacob” (“Israel”) through the right faith in the Christ AND the right works in the Commandments (James 2:14-26) in order for a Gentile to be called one of the “elect” or “saints” (Galatians 3:29). The True Messiah/Christ was a “Jew” who Founded Ancient “Nazarene Unitarian Judaism”, aka, “Jewish Unitarian Christianity” (Matthew 2:23; Acts 3:19 4:24:5, 14; 15:3; 28:22-23; Psalm 19:7). The “Remnant of God”, as written in the “Bible”, is the “Remnant of Israel” who are called “the elect”/“the saints”, whom God Has Chosen for the very


Purpose of Raising up the Messiah/Christ from “Jacob’s Seed” (Isaiah 10:20-22; 11:10-16; 46:1-9). The “Remnant of Israel” includes some Israelites, some Jews, and some Christians and/or Gentiles who continue to, have their faith of allegiance in the Christ, AND have their works of obedience in the Commandments (Revelation 12:17; Revelation 14:12).

The “True Jews”, including the Israelites, Jews, Christians and/or Gentiles who, have the right faith in the Christ of Righteousness AND the right works in the Commandments of Righteousness, respectively, MUST go through the God-Ordained “Conversion Process” BEFORE their physical life ends in order to, be raised in the 1st Resurrection as an Everlasting Angelic “son (or daughter) of God”, and be “Born Again” WHEN the True Messiah/Christ RETURNS to Earth soon, and very soon!

The True Identity of the “Remnant of God” (“True Jews”), as “Natural Israel”, MUST be accepted by True Worshipers who ONLY worship the One True (Father) God in Spirit and in Truth (John 4:4-24; Revelation 2:9; Revelation 3:9; and Revelation 12:17; 14:12). Hence, “Natural Israel” includes Israelites, Jews, Christians and/or Gentiles who, 1, worship ONLY The Father in Spirit (in the Christ) and in Truth (in the Commandments), and 2, have been “set apart” by The Father through their choice to receive the Indwelling of the holy “Spirit” (“Holy Ghost”) of the Christ, which gives true evidence of the altruistic, loving, and merciful “Fruit” of the Christ (Galatians 5:22-23), toward all kinds of different Peoples, on a daily basis! Therefore, a True Worshiper MUST (a.) “bare” (give true evidence of) the non-discriminating, torah-keeping, altruistic, loving, and merciful, “Fruit” of the Christ, the Jewish Hebrew Prophet who is the son of The Father and (b.) “find” (reach and teach) the humble, “Branches” of the Christ — the Christ being the main, “Branch” (“Vine”) from The Father — which allows The Father to “graft”

the “Natural Branches” (Israelites and Jews), and the “Un-natural Wild Branches” (Gentiles and/or Christians) “into” the One, “Olive Tree” of Righteousness, which Is the Reunited Righteous, “Assembly of Israel” — the Reunited Righteous “Ecclesia of God”, which includes Israelites, Jews, Gentiles and/or Christians — that will be “added into” the Reunited Righteous, “Kingdom of Israel” that the Christ will Restore when he Returns to EARTH, which is in the Reestablished Righteous, “Kingdom of God” that the Christ will Reign over for 1,000 Years when the Christ Returns to EARTH at the time of the “First Resurrection”.

NOWADAYS, there are “True Jews” of Arabian-descent, and “True Jews” of Asian-descent, and “True Jews” of African-descent, and “True Jews” of Arabian-African-Asian-descent, and “True Jews” of Arabian-African-Asian-European-descent, and “True Jews” of European-descent!




Nowadays, a “True Jew” is NOT a “True Jew” based upon their outward appearance, or their biological lineage, or adherence to Judaism. Nowadays, a “True Jew” is MOST CERTAINLY a

“True Jew”, not because of their outward appearance, but, because of their inward and outward adherence to the Two-Fold “NEW COVENANT” that the God of Israel, in the “Bible”, Has Made with the “True Jews”, which includes placing their “faith” of allegiance in the “Jewish” Christ of Everlasting Righteousness, AND placing their “works” of obedience to the “Jewish” Commandments of Everlasting Righteousness (Exodus 20:1-17; Exodus 23:20-33; Deuteronomy 6:25; Isaiah 51:1-6; Jeremiah 31:31-33; Matthew 5:17-19; Romans 2:28-29; Romans 3:22, 31; Romans 6:15-16; 7:12; 1st Timothy 1:8; James 2:14-26; Revelation 12:17; Revelation 14:12; Revelation 2:9; Revelation 3:9; 1st John 5:3). I REPEAT: Nowadays, a “True Jew” is MOST CERTAINLY a “True Jew” based on their inward and outward adherence to the Two-Fold “NEW COVENANT” that the God of Israel, in the “Bible”, Has Made with the “True Jews”, which includes placing their “faith” of allegiance in the “Jewish” Christ of Everlasting Righteousness, AND placing their “works” of obedience to the “Jewish” Commandments of Everlasting Righteousness. Additionally, the “True Jews” who adhere, inwardly and outwardly, to the God of Israel’s Two-Fold “NEW COVENANT” will MOST CERTAINLY ABANDON AND DENOUNCE “Babylonian, Binitarianism, Trinitarianism, Sunday-ism, Christmas-ism, Easter-ism, Unclean-ism” (Jeremiah 51:6; Jeremiah 51:45; 2nd Corinthians 6:17; Revelation 18:4). REMEMBER, the “True Christ” said that, “Salvation is of (for) the (True) JEWS” (John 4:22). THEREFORE, “True Christ Followers” adhere, inwardly and outwardly, to the God of Israel’s Two-Fold “NEW COVENANT” = their “faith” in the “Jewish” Christ, AND their “works” in the “Jewish” Commandments (James 2:14-26).

The whereabouts of the Original Ancient “True Jews” of brown-skinned, and black-skinned, colours have been found, because they were never really lost — they had lost their “True Identity”

as being the First Peoples called Original, “Jews”, and “Israelites”, and “Nazarenes”, in the “Bible” (Isaiah 11:11-12; Matthew 2:23; Acts 1:8; 2:4-11).

It is a very well known Biblical Fact that the man named “Ham”, in the “Bible”, was a black man! Hence, all of the direct descendants of “Ham”, which lived in Ancient Asia and in Ancient Africa, were black Peoples from the following Lands: Ethiopia-Africa, Egypt-Africa, Libya-Africa, Canaan-Asia, Assyria-Asia, Mesopotamia-Asia, Chaldea-Asia, Babylonia-Asia, India-Asia, China-Asia, etc. All of these Peoples were, either, dark-brown-skinned black Hamitic Africans, or, reddish-brown-skinned black Hamitic Asians, respectively, because they all descended from the black man named “Ham” (Genesis 10:6-20). Therefore, all of those descendants of “Ham” who were from the Lands of Ancient Asia were black Peoples, and all of those descendants of “Ham” who were from the Lands of Ancient Africa were, also, black Peoples! Altogether, the black Hamitic Peoples of Ancient Africa and Ancient Asia, as a whole, were, originally, known as “black Hamitic Peoples” in the “Bible”! Some of the descendants of “Ham”, who were brown-skinned Hamitic Peoples of Ancient Asia, did intermarry and interbreed with some brown-skinned Semitic Peoples of Ancient Arabia, and some black-skinned Hamitic Peoples of Ancient Africa! Therefore, “Ham’s” descendants have interbred with “Shem’s” descendants.



It is, also, very important to know that the lineage of the True Messiah/Christ, definitely, had black Hamitic and black Canaanite bloodlines, which were biologically/genetically interbred with the black Semitic bloodlines of Abraham and Isaac and Jacob, in order to produce the Hamitic-Semitic black Peoples of the True, Twelve Tribes of Israel as follows.

According to the sacred scriptures in the Bible, we can be, absolutely, certain (100%) that the man named Judah (also called “Judas” in Matthew 1:3: the son of the Semitic brown-skinned man named “Jacob”) had a son by the Hamitic black Canaanite woman named Tamar. (“Thamar”) who had a son named Pharez (“Perez” / “Phares”), a “mixed” half-black Hamitic-Semitic Israelite man with black Canaanite blood (Genesis 38:1-30; Matthew 1:2-3).

One of the sons of of the black man named Canaan is named “Heth” (both Canaan and Heth were descendants of the black man named Ham), and the descendants of the black Canaanite man named “Heth” were the Hamitic black Canaanites, in the “Bible”,

called “Hethites” (aka, Biblical “Hittites” / “Hethites”) as referenced in Genesis 10:6-18.

It is, also, very important to know that the Ancient Israelite Peoples NEVER, NEVER, NEVER, had children from a Japhethic-Gentile, or Japhethic-Samaritan, or Japhethic-Edomite, BEFORE the Christ was sent to the (Jewish) Ancient Israelite Peoples! You will notice that, instead, the Ancient Israelite Peoples would have children from a brown-skinned Semitic Israelite, or from a dark-skinned Hamitic Egyptian-African, or from a dark-skinned Hamitic Ethiopian-African, or from a dark-skinned Hamitic Canaanite-Asian, as in the case of a Semitic Israelite man’s “concubine” and/or the “handmaiden” of the wife of a Semitic Israelite man. The “concubine” and/or “handmaiden” in these cases were the result of the Semitic Israelite Peoples having “servants” from the “tribal warriors” whom they defeated in battle. In fact, Zilpah and Bilhah were Hamitic black women from the “concubines” of Jacob, and “handmaidens” of Jacob’s wives. Hence, Zilpah and Bilhah gave birth to Hamitic-Semitic black Israelite children who became some of the Hamitic-Semitic black Israelite descendants of “Jacob” (Genesis 30:1-43).

King David was a Hamitic-Semitic black Israelite man with black Canaanite lineage, because King David was a descendant of a Hamitic black Canaanite woman whose name was Tamar (“Thamar”); and King David was, in fact, a direct descendant of the Semitic brown-skinned man named Jacob. Also, King David begat a child named Solomon who was the son of a Hamitic black Egyptian African woman named Bathsheba who was a descendant of the Hamitic black man named “Ham” (Genesis 10:15-18).

Additionally, King Solomon was a Hamitic-Semitic black Israelite man who had a black Canaanite lineage, because King Solomon was a direct descendant of a Hamitic black Canaanite

woman named Tamar (“Thamar”); and King Solomon was a descendant of a Hamitic black Egyptian African woman named Bathsheba; and King Solomon was, also, a descendant of the Semitic brown-skinned man named Jacob,.

Furthermore, King Solomon begat Rehoboam (“Roboam”) who was a Hamitic-Semitic black Israelite man with Hamitic black Canaanite lineage, and Hamitic black Ammonite lineage, because Rehoboam (“Roboam”) was a direct descendant of the Hamitic black Canaanite (“Hethite”) woman named Tamar (“Thamar”), and Rehoboam (“Roboam”) was the direct descendant of the Hamitic black Egyptian African woman Bathsheba, and Rehoboam (“Roboam”) was the son of a Hamitic-Semitic black Ammonite woman named Naamah, — the brown-skinned Semitic Ammonites (descendants of “Lot”) interbred with descendants of Hamitic black Canaanite Peoples — (Ezra 9:1-2; 1st Kings 14:21-31), and Rehoboam (“Roboam”) was a descendant of the brown-skinned Semitic man named Jacob (Ruth 4:12-22; 2nd Samuel 11:1-27; 2nd Samuel 12:1-24; 1st Samuel 17:12; Matthew 1:1-7; Luke 3:23-38).

Originally, the Peoples in the “Bible” who were “brown-skinned Semitic Peoples” were called the “Arabians”. The “Bible” shows us how “Abraham’s” concubine wife named “Hagar” was a black African Egyptian who was the mother of a black African-Arabian named “Ishmael”. After “Abraham’s” wife named “Sarah” died, “Abraham” married a black African Egyptian, or black Asian Canaanite, woman named “Keturah” who was the mother of black African-Arabian/black Asian-Arabian children. In this way, Biblical Semitic Arabians continued to intermarry and interbreed with Biblical Hamitic black Africans and/or Biblical Hamitic black Canaanites, the offspring of which were called “Negroes” (aka, “Negritos”) who, eventually, were referred to as “black Peoples with a black Canaanite curse”. These so-called “black

Peoples with a Canaanite curse” were, initially, referred to as “Palestinians” and/or “Israelites” and/or “Orientals”, by the European Gentiles, up until the time of the First World War, regarding the Hamitic-Semitic black Peoples who resided in “Northern Africa”, “Asia Minor” and “East Asia”. Eventually, the Land of Canaan, and the Land of Assyria, and the Land of Babylonia, and the Land of Mesopotamia, and the Land of Chaldea, and the Land of Arabia, altogether, became known as “the Middle East”. Earlier, between the 15th and the 17th Centuries AD/CE, many black Israelites, who were called “Negroes” (“black Peoples with a black Canaanite curse”), were also referred to as “black gold” due to their value as so-called “cursed slaves”. These black Israelites were captured, scattered, bought and sold throughout “the four corners of the Earth” via the Trans Atlantic Slave Trade. Hence, the Original Arabian Semitic Israelite Peoples of Abraham, which intermarried with some Northeast-African, South-Asian, and West-African, Hamitic Peoples of Ham and Canaan, were called “Negroes”, and are, today, referred to as “black Peoples from the Lineage of the True, Twelve Tribes of Israel”.

Therefore, according to the sacred scriptures in the Bible, we can be, absolutely, certain (100%) that the Messiah (“Christ”),

Yahuwah-sha, or Yahuw-ah-sha (aka, “the Christ”, or “Je-sus”) was, in fact, a Hamitic-Semitic black Israelite man who had brown-skinned Semitic Arabian bloodlines, and dark-skinned Hamitic Egyptian-African bloodlines and dark-skinned Hamitic Canaanite-Asian bloodlines!

Those people who have been taught, and continue to hold on to, prejudiced and racist teachings, which claim that “black Peoples”, or “brown Peoples”, who descended from “Ham” are supposedly “inferior” to the “white Peoples”, MUST stop all those wrong teachings of their “group”, and MUST get rid of those wrong attitudes of their “heart” associated with such prejudiced and racist teachings! Some of these bigoted fear-based teachings include the false fable of “British-Israel-ism”, or “Anglo-Saxon-Israel-ism”. [Request and read my Bible Study Paper called “The ‘British-Israel-ism’ fable is FALSE!”]

Yah-uw-ah-sha, the Messiah (Christ), had Arabian-Semitic, and Asian-Hamitic, and African-Hamitic bloodlines in his Biblical-Biological Lineage, which would cause him to be identified and classified as a “black Man”, aka “black Messiah”, by today’s European Gentile standards of “ethnic classification”, which includes, 1, Caucasoid (“Aryan”/”Albino”, and “Northern European”, and “Western European”, and “Southern European”, and “Eastern European” and “South Asian”, aka “Indo-European”), and 2, Mongoloid (“East Asian”, and “Southeast Asian” and “Aboriginal American”/North American, and Central American, and South American, “Aboriginals”), and 3, Negroid (“Coloured” and/or “Black”), and 4, Australoid (“Aboriginal Australian”, which has often been classified as Caucasoid). The “Bible” says that out of two people, “Adam” and “Eve”, came the one human family, also known as the one human race. Hence, there are not four human races! There is ONLY one human race — one human family of three main extended families. With

respect to the “Arabian” Peoples, the “Arabians” were always called “Coloured” Peoples for thousands of years until “West Asia” was recently “renamed” into what is now called the “Middle East”. Since then, they have been called “Middle Eastern” Peoples, or “Arabs”. Many of today’s “Arabs” have been intermarried/interbred with the Caucasoid ethnic group, but they are NOT considered to be “Europeans” or “South Asians”. Hence, “Ancient Arabians” and “Modern Arabs” are actually/secretly classified under the Negroid ethnic group, by the Caucasoid ethnic group, and not under any of the other three aforementioned ethnic groups! Therefore, the “Semitic” Peoples who are truly biological descendants of “Shem”, and are truly biological descendants of “Abraham”, were originally Ancient Arabian Peoples who later became many Peoples of many Nations, especially throughout the part of the world, now called the “Middle East”, that used to be called “West Asia”, which included the Ancient Israelite Hebrew Peoples also known as the “Jews” (John 4:5-22, KJV). During Ancient Times, there were some Peoples from the Caucasoid ethnic group, who were descendants of “Japheth”, that were “converted” to a form of “Judaism” and were considered as “Jews” due to their “Adherence to Judaism” although they were NOT descendants of “Shem” or “Jacob”. Hence, they may have been called “European Jews” but they were NOT Semitic. There were other Peoples from the Caucasoid ethnic group, who were descendants of “Japheth”, that were “converted” to a form of “Judaism” and were considered as “Jews” due to their “Adherence to Judaism” and they were descendants of “Shem”, but they were NOT descendants of “Jacob”, because they were descendants of “Esau”. They, also, may have been called “European Jews”, but as descendants of “Esau” they were NOT “True Jews” (Revelation 2:9; Revelation 3:9, KJV), because they were NOT the descendants of “Jacob”. Oftentimes, during the time of the Christ, the descendants of “Esau” would infiltrate the ranks of

Political Leadership (Herod’s Family) and Religious Leadership (Jewish Sanhedrin) within the Ancient Roman Empire, but they were “Edomites” who were NOT “Israelites”. These “Edomites”, who were “Semitic”, later, intermarried/interbred with the “Aryans”/“Albinos” or “Southern Europeans” or “Northern Europeans” or “Central, and Eastern, Europeans” of the Caucasoid ethnic group, as in the case of Hitler’s family, in order to hide their “Edomite” identity and exterminate those with an “Israelite” identity. There were, also, some Peoples from the Caucasoid ethnic group, who were descendants of “Japheth”, that became descendants of “Shem” through their intermarrying/interbreeding with Hamitic-Semitic Peoples from the Negroid ethnic group who were descendants of “Jacob” and/or “Judah” and, as a result, produced Jewish Peoples of very light brown-skinned and yellow-skinned bloodlines that had settled in “Central Asia” and “Northwest Africa”. Many of these Hamitic-Semitic “European Jews”, some of whom had very little visible traits of the Negroid ethnic group but had Negroid ethnic blood types, had been “transported” to Southern Europe and some migrated, later, to Australia and the United States of America, while others were killed in the Jewish Holocaust by Hitler and his Nazi henchmen. These same Hamitic-Semitic “European Jews” of the Negroid ethnic group intermarried/interbred with “European Jews” of the Caucasoid ethnic group and, therefore, they look more like those of the Caucasoid ethnic group. These Hamitic-Semitic “European Jews” are “True Jews”. We are intelligent enough to know that when Adolph Hitler claimed to be a “Frankish Jew” (“European Jew of French-descent”) he was letting certain Peoples of the Caucasoid ethnic group know that he was a descendant of “Japheth”, and although he was also a descendant of “Shem” through “Esau” who was the progenitor of “Semitic Edomites”, he made it clear that he was NOT a descendant of the “Hamitic-Semitic Israelites”. The Peoples who are from the “Semitic Edomites” through “Esau” are NOT “True

Jews”, because they are NOT from the “Hamitic-Semitic Israelites” through “Jacob”. Hitler was sending a world wide message of so-called “ethnic cleansing” for the “Revised German-Roman Empire”, which hoped to “exterminate” the “Jews” who had Negroid bloodlines that were “mixed” with Caucasoid bloodlines. Hitler wanted to, somehow, “wash” the “yellow, and brown, and black, colours” out of his so-called “superior, colourless, master race”. Interestingly, before European-Gentile standards of ethnic classification were “institutionalized” by European-Gentile Empires, the God of the Hebrews, in the “Bible”, Ordained that there would be three main “Family Heritages”, which included the Heritage of “Ham”, the Heritage of ‘Japheth” and the Heritage of “Shem”, according to God’s ANCIENT HEBREW PERSPECTIVE. These three “Family Heritages” all had bloodlines that came from “Adam” and “Eve” through “Noah”. It is a genetically proved fact that “Adam” and “Eve” produced AB, NO AO and OO blood types that began in Africa and then spread to “West Asia” (“Asia Minor”).

Therefore, “Noah”, “Ham”, “Japheth” and “Shem” all had dark-brown, or reddish-brown, skin colours. Hence, there were NEVER any distinctions or different classifications made between them with regards to skin colour or hair texture or facial features, until the time of the Ancient Roman Empire! The Original, Biblical, “Family Heritages” were given in the order of the children’s ages, which would allow the oldest son to receive the biggest inheritance of “Royalty” and “Property” from his biological father. In the case of the generations of “Noah”, it was “Ham”, the first-born, who received the biggest inheritance which included the Hamitic “Seat of Royalty” and all the Hamitic Lands including East Asia, Southeast Asia, South Asia, West Asia (Asia Minor), North Africa and East Africa. The second-born son of “Noah” was “Japheth”; and “Japheth” received the “Islands of the Gentiles” which included the Islands of the Mediterranean Sea

and the Lands of Southern Europe. The third-born son of “Noah” was “Shem”; and “Shem” received the Semitic Land of “Arabia” (Genesis 10:1-32, KJV). I reiterate, there were NO different ethnic groups, and there were NO different races! There was ONLY one human family of three main extended families. Therefore, the extended family of “Ham” had reddish-brown-skinned Asians and dark-brown-skinned Africans in the Original God-Ordained “Seat of Royalty” on Earth. The extended family of “Japheth”, and the extended family of “Shem” did NOT receive the Original God-Ordained Hamitic “Seat Of Royalty” on Earth! It wasn’t until the extended family of “Shem” intermarried/interbred with the extended family of “Ham” in order for the God-Ordained “Seat of Royalty” to be passed over to a Hamitic-Semitic “Seat of Royalty” through which the Christ would be birthed on Earth.

Do you now understand why the Edomite King Herod, and the German President Adolph Hitler did everything possible to try “exterminating” the “Jews” who came from the Original God-Ordained Hamitic-Semitic “Seat of Royalty” whether those “Jews” were of European-descent, or Arabian-descent, or Asian-descent or African-descent! Adolph Hitler knew that the Original Jews/Israelites, in the “Bible”, were, what he called, the “Oriental Negroid Peoples” from “black Hamitic” (and Semitic) Heritage. Adolph Hitler knew that the “white Slavic Peoples” (from the “white Slavic Countries” of Central Europe, and Eastern Europe) who chose to accept, and adhere to, “the black Man’s Religion” of “Hebrewism”, or “Palestinian Judaism”, were known as the “Slavic Jews” whom Hitler knew were NOT the Original Jews, or Israelites, of the “Bible”. In fact, the “Slavic Jews” were taken into captivity/slavery by the Ancient Gentile European Empires. Hitler, also, knew that the “Sephardic Jews” (of Arabian-descent) were NOT the Original Jews, or Israelites, of the “Bible”. Hitler called the “Slavic Jews” and “Sephardic

Jews” by a derogatory term meaning “imposters”. Hitler called his brand of Jews the “Ashke-nazi Jews”. Hence, the term “Nazi” was coined by Hitler and his Nazi Henchmen in order to let all the world know that he (Hitler) was a white-skinned, Semitic Edomite person called an “Ashkenazi Jew” of European French-descent who was obsessed with exterminating/killing all the yellow-skinned, white-skinned, brown-skinned, and black-skinned, Hamitic-Semitic Israelite Peoples, most of whom are “True Jews”. Adolph Hitler knew, along with his Zionist Elitist Cohorts, that these “Slavic Jews” and “Sephardic Jews” were a barrier to him conquering and ruling the whole wide world along side of his Zionist Elitist Cohorts who were also “Ashkenazi Jews”. Obviously, the “Ashkenazi Jews” (most of whom are actually “Edomite Jews” from “Western Europe” or “Southern Europe” or “Northern Europe”), are NOT the “Biblical Jews”, and are NOT the “True Jews” and, likewise, the so-called “British-Israeli Jews” are NOT the “True Jews” (Revelation 2:9; Revelation 3:9).

This is, exactly, why certain European Empires decided to concoct the “systemic philosophy” of different races, one of which was supposedly superior to the others in a “graded” top-to-bottom “system”. The top race was supposedly the Caucasoid race, which had a “graded” top-to-bottom “system” within itself, that placed the “Aryans”/“Albinos” at the top, which was followed in the top-to-bottom order of “Northern European”, “Southern European”, “Western European”, “Central, and Eastern, European” and “Indo-European” (“South Asian”). Hence, the so-called Caucasoid “race” (ethnic group), which was supposedly the “master race”, had a “master class” within itself which was supposedly above, and far more privileged, than the other “classes” within the Caucasoid “race”. The other so-called “races” which had other so-called “classes” were supposedly below, and far less privileged, than the other “races” and

“classes” in a top-to-bottom graded “system”. This was the basis of the evil, systemic and racist “caste system” which was “institutionalized” by the British Empire in India before the Hamitic “brown man” named Mahatma Gandhi stood against it, and put a stop to it! Later, the Hamitic “black Man” named Martin Luther King Junior stood against it, and put a stop to it in the United States of America! We must accept the biblical proof that in Ancient Times some of the “Semitic” descendants of the “brown Man” called “Judah” intermarried/interbred with some of the “Hamitic” descendants of the “black Man” called “Ham” (“Canaan” – black Hamitic West Asians, and “Mizraim” – black Hamitic Egyptian Africans). Therefore, “Moses”, and “King David”, and “King Solomon” and the Christ (aka, “Je-sus”) did, in fact, have a “Hamitic” Lineage “mixed” with a “Semitic” Lineage in their “DNA”, which made them “Hamitic-Semitic” Peoples of “mixed” brown-skinned, and black-skinned bloodlines.

Later, the Ancient Roman Empire “adopted” the teachings of the Christ and “merged” them with the religion of Ancient Roman Mithraism, which became Ancient Roman Catholicism. The Ancient Roman Catholic Church “changed” the pictures and artifacts of the Israelite Hebrew Peoples of the “Bible” from brown-skinned and black-skinned images, into white-skinned images. However, the Israelite Hebrew Peoples of the “Bible” were, originally, a Hamitic-Semitic “mixed multitude” of “brown” and “black” Jewish Peoples whom would be “classified”, by the so-called Caucasoid “race”, today, as Negroid Peoples. One of their descendants called “Mary” gave birth to the Christ who descended from the same Negroid Peoples that were also called “Jews” by the so-called Caucasoid “race” (Exodus 12:38), KJV. [“With respect to my own identity, as the author of this website, I have Arabian-Semitic, Asian-Hamitic, African-Hamitic, and European-Gentile, ‘mixed’ bloodlines in my Biological Lineage of Hamitic-Semitic Israelite Heritage, but I’m

still classified as a ‘black Man’, within the Negroid ethnic group, by today’s European-Gentile standards of ‘ethnic classification’. Thus, because the Christ did in fact have Arabian-Semitic, Asian-Hamitic and African-Hamitic ‘mixed’ bloodlines, then, he would, absolutely, be identified and classified as a ‘black Man’ in the, exact, same way I am identified and classified as a ‘black Man’. This is why I chose to, accept the Ancient Hebrew Perspective concerning God’s Truth and Grace, and accept my new name ‘Aliyahu Bin Ab-rua-ham’ in Hebrew (‘Elijah, son of Abraham’ in English); Amen.”] Many of the descendants of “Jacob” who are living today, throughout the “African Diaspora” outside of Africa, are descendants of the “black Slaves” who were captured and forced to work for NO pay on Agricultural Plantations throughout many countries in the world that European Empires have conquered and controlled and colonized. Certainly, not all of these “black Slaves”, and not all of their descendants, were the descendants of “Jacob”. However, the majority of these “black Peoples”, who’ve been wrongly oppressed and brutally mistreated, are actually “True Jews” descended from “Jacob”, but they are NOT aware of, or they do NOT accept, their Original True “Israelite Identity” as “black” Hamitic-Semitic “Jewish” Peoples. Most do NOT accept the fact that Messiah (Christ) was a “black” Hamitic-Semitic “Jewish” Person who looked very much they look — with reddish-brown burnt bronze-coloured skin and curly hair like lamb’s wool — and therefore would certainly be called a “black Man” (or “black Messiah”), today, by almost all Peoples (Genesis 2:7-15; Leviticus 26:14-46; Deuteronomy 28:15-68; Isaiah 11:10-13; Luke 3:23-38; Acts 2:5-11; Revelation 1:14).

The Truth of the matter is that, the Messiah (“the Christ”) was a Hamitic-Semitic black Israelite man who had Hamitic dark-skinned Canaanite-Asian lineages, and Semitic brown-skinned Arabian lineages, and dark-skinned Hamitic Egyptian-African lineages. Therefore, the Messiah (“the Christ”) was, what we would, today, call “a black Man”!!!!!!

The following Biblical Scriptures provide verifiable evidence that the Messiah/Christ was, in fact, a “black Man” based on his Biblical Genealogy: Genesis 38:1-29; Genesis 46:12; Ruth 4:12; Matthew 1:3; Luke 3:23-38; Romans 3:4-9; 2 Samuel 5:14; 1 Chronicles 3:5; 1 Chronicles 14:4; 1 Kings 3:1; 1 Kings 14:21-31; 2 Chronicles 12:13.

In Daniel 7:19 and in Revelation 1:15 we read that the skin colour of the Messiah/Christ is as burnt brass, which is very dark brown, and his hair texture is kinky like the wool of a lamb!

HIDDEN TRUTH, FORBIDDEN IN MOST ABRAHAMIC RELIGIOUS ORGANIZATIONS:

Three Major World Religions claim an Ancient Semitic Prophet, whom they call “Abraham”, as their “spiritual father” with respect to a “common bond”, supposedly, between the three so-called “Abrahamic Religions” called “Judaism”, “Christianity” and “Islam”. Obviously, the man, whom the “Bible” calls, “Abraham the Hebrew” was a Semitic Hebrew, from the Lineage of “Shem”, because the “Bible” tells us that he was a Semitic Hebrew Warrior named “Ab-ram”, which means “prideful/boastful father”, before he accepted his God-Given name “Abraham” (“Ab-rua-ham”) as in Genesis 10:21-31, Genesis 14:13-17 and Genesis 17:1-9. In fact, the English word “Hebrew” in the Hebrew Language is “abar” (“eber” in the Assyrian Language), which means “to cross over”, or “to transgress”. Therefore, the man of Semitic Lineage called “Ab-ram” would choose “to transgress” against the God of the Hebrews and, later, he would be allowed, by the God of the Hebrews, “to cross over” to the Hamitic Lineage. God Told “Ab-ram” to no longer call his Semitic Hebrew wife by the Semitic name “Sa-rai”, which means

“contentious/quarrelsome”, and instead, call her by the Hamitic name “Sar-ah”, which means “of Royalty”. God Told the Semitic Hebrew man named “Ab-ram” that, his Semitic Hebrew wife named “Sa-rai” would soon have a son, and she would eventually have many descendants who would have many kings and many people as “her” descendants although at that point in time her womb was infertile/barren. “Ab-ram”, accepts his God-Ordained name “Ab-rua-ham”, which means “Ham’s new father”. However, because of the fact that he had been so prideful/boastful all those prior years, it was still in his self-righteous egotistic nature to laugh at, and mock, the God of the Hebrews (Genesis 17:15-20). Of course, this was a big “transgression” (“sin”) that “Ab-rua-ham” committed against the God of the Hebrews and, therefore, the God of the Hebrews would have to “humble” the Semitic Hebrew man who had just recently accepted his new Hamitic name — “Ab-rua-ham”. Soon afterwards, “Ab-rua-ham” travelled into the Land of Philistia, and “Ab-rua-ham” said that “Sar-ah” was his sister for fear of being killed by the Philistine “black Man”, the Hamitic Pharaoh/Prince of Philistia. This too was a “transgression” (“sin”) that “Ab-rua-ham” committed against the God of the Hebrews. The significance of this matter was that the Hamitic Pharaoh/Prince of Philistia took “Sar-ah” and intermarried/interbed with her not knowing that “Sar-ah” was already the wife of “Ab-rua-ham”. During the days when the Ancient Hamitic Egyptian African Empire had conquered and controlled and colonized most of the “Old World”, the Ancient Hamitic Egyptian African Empire also took control of the Land of Philistia (“Territory of the Philistines”). Therefore, the Philistines were a “black Peoples” of Hamitic Egyptian African “Heritage of Royalty”. Soon after the Hamitic Pharaoh/Prince of Philistia found out that “Sar-ah” was already married to “Ab-rua-ham”, he gave “Sar-ah” back to her husband “Ab-rua-ham” and, then, had them leave the Land of Philistia and go back to the Land of Canaan. The only problem

was, the Hamitic Pharaoh/Prince of Philistia had already “impregnated” the Semitic woman whose Semitic name had become the Hamitic name “Sar-ah” — the wife of “Ab-rua-ham”. Nevertheless, “Ab-rua-ham” and “Sar-ah” gave the baby the Hamitic name “Yits-hah” (pronounced “Yits-kak” in Hebrew), which means “laughter” (“Isaac” in English). Chapter 20, in the Book of Genesis, in the “Bible”, was, absolutely and most certainly, “altered” by the “Thespian Theologians” of the Ancient Gentile European Empires so that they could “distort the truth” and, also, “hide the truth” from the descendants of “Jacob” concerning the true identity of Hamitic-Semitic “black Peoples” who are a brown-skin-coloured, and black-skin-coloured, Peoples that are called “Israelites” and/or “Jews” and/or “Nazarenes” in the “Bible”. Again, we can see how the “Thespian Theologians” of the Ancient European Empires changed the biblical account of “Ab-rua-ham” and his son “Yits-hah” (“Isaac”) into a fictional story of how the God of the Hebrews, supposedly, Told “Ab-rua-ham” to kill “Yits-hah” (“Isaac”), and at the last moment, supposedly, Told “Ab-rua-ham” not to kill his son. If you can believe that fictional story, then, you can believe the fictional story that says the God of the Hebrews is, somehow, not Existing anymore. The reason why I say this is, because the God of the Hebrews Has Told all humankind to NOT kill innocent humankind (Exodus 20:13) and, therefore, the God of the Hebrews would NEVER turn around and, somehow, Tell “Ab-rua-ham” to kill an innocent human

baby that had NO sin and NO iniquity! Furthermore, the God of the Hebrews Told all humankind that He Will NEVER “tempt” any person (James 1:13-15). God CANNOT tell lies, and God CANNOT speak confusion (Numbers 23:19; 1st Corinthians 14:33; Titus 1:2). Originally, the descendants of “Japheth” were ONLY given the “isles of the Gentiles” from “Noah” and, therefore, did NOT have a “Heritage of Royalty”, and the descendants of “Shem”, originally, were ONLY given one nation (“Arabia”) from “Noah” and, therefore, did NOT have a “Heritage of Royalty”, because “Noah” gave the “Heritage of Royalty” to, his first born son called “Ham”, and the descendants of “Ham” who were given many nations from the inheritance of “Ham” (Canaan, Jordan, Lebanon, Babylonia/Iraq, Mesopotamia/Turkey, Assyria/Syria, Persia/Iran, Chaldea, India, East Asia, Egypt, Ethiopia, Libya, etc.) from “Ham”. However, the God of the Hebrews Gave the Land of Canaan, which was initially one of the Lands of “Ham”, to the descendants of “Yah-kab” (“Jacob”) who were, originally, the brown-skin-coloured, and black-skin-coloured, Hamitic-Semitic Peoples called “Israelites” and/or “Jews” and/or “Nazarenes”, in the “Bible” (Genesis 26:1-6; Genesis 29:16-35; Genesis 30:1-24; Genesis 50:24-25; Exodus 1:1, 7; Exodus 12:37-38; Numbers 11:4;). Therefore, the God of the Hebrews NEVER Gave the Land of Canaan to all of the Lineages of “Shem”, because the God of the Hebrews Gave the Land of Canaan to ONLY one Lineage of “Shem”, which was the Hamitic-Semitic brown-skin-coloured, and black-skin-coloured, Peoples called “Israelites”, “Jews” and/or “Nazarenes”, in the “Bible”, who have “struggled with God” (Y’sra-al) till this day. You will see WHY and HOW some of the descendants of “Ishmael”, who’ve practiced the doctrines of a former “Islamic” Arabian Empire, have gone into some of the Lands of “Ham” and “Shem” while forcing them to convert to the Religion of “Islam” or die; and they have, also, gone into the Lands of “Ham” and “Shem” conquering, controlling and colonizing — not to mention taking part in the evil “Trans Atlantic black Slave Trade”. You will see WHY and HOW the “Eurocentric” Empires/Super Powers are, progressively, establishing a Satanic “New World Order”, which is Anti-Hamitic and Anti-Semitic and Anti-Protestant and Pro-Fascism, as they continue to try eliminating any trace of the “Old World Order”, which was Hamitic “Afro-asiatic” and Semitic “Afro-arabic” and Hamitic-Semitic “Afro-asiatic-arabic”. I Repeat: Today’s so-called standards of “racial classifications”, which the Gentiles of European-descent have institutionalized, are as follows: 1, Caucasoid (“Aryan”/”Albino”, and “Northern European”, and “Western European”, and “Southern European”, and “Eastern European” and “South Asian”, aka “Indo-European”), and 2, Mongoloid (“East Asian”, and “Southeast

Asian” and “Aboriginal American”/North American, and Central American, and South American, “Aboriginals”), and 3, Negroid (“Coloured” and/or “Black”), and 4, Australoid (“Aboriginal Australian”, which has often been classified as Caucasoid). The “Bible” says that out of two people, “Adam” and “Eve”, came the one human family, also known as the one human race. Hence, there are not four human races! There is ONLY one human race — one human family of three main extended families. With respect to the “Arabian” Peoples, the “Arabs” were always called “Coloured” Peoples for thousands of years until “West Asia” was recently “renamed” into what is now called the “Middle East”. Since then, they have been called “Middle Eastern” Peoples, or “Arabs”. Many of today’s “Arabs” have been intermarried/interbred with the Caucasoid ethnic group, but they are NOT considered to be “Europeans” or “South Asians”. Hence, “Ancient Arabians” and “Modern Arabs” are actually/secretly classified under the Negroid ethnic group, by the Caucasoid ethnic group, and not under any of the other three aforementioned ethnic groups! Therefore, the “Semitic” Peoples who are truly biological descendants of “Shem”, and are truly biological descendants of “Abraham”, were originally Ancient Arabian Peoples who later became many Peoples of many Nations, especially throughout the part of the world, now called the “Middle East”, that used to be called “West Asia”, which included the Ancient Israelite Hebrew Peoples also known as the “Jews” (John 4:5-22, KJV). During Ancient Times, there were some Peoples from the Caucasoid ethnic group, who were descendants of “Japheth”, that were “converted” to a form of “Judaism” and were considered as “Jews” due to their “Adherence to Judaism” although they were NOT descendants of “Shem” or “Jacob”. Hence, they may have been called “European Jews” but they were NOT Semitic. There were other Peoples from the Caucasoid ethnic group, who were descendants of “Japheth”, that were “converted” to a form of “Judaism” and were

considered as “Jews” due to their “Adherence to Judaism” and they were descendants of “Shem”, but they were NOT descendants of “Jacob”, because they were descendants of “Esau”. They, also, may have been called “European Jews”, but as descendants of “Esau” they were NOT “True Jews” (Revelation 2:9; Revelation 3:9, KJV), because they were NOT the descendants of “Jacob”. Oftentimes, during the time of the Christ, the descendants of “Esau” would infiltrate the ranks of Political Leadership (Herod’s Family) and Religious Leadership (Jewish Sanhedrin) within the Ancient Roman Empire, but they were “Edomites” who were NOT “Israelites”. These “Edomites”, who were “Semitic”, later, intermarried/interbred with the “Aryans” or “Western Europeans” or “Northern Europeans” or “Southern Europeans” of the Caucasoid ethnic group, as in the case of Hitler’s family, in order to hide their “Edomite” identity and exterminate those with an “Israelite” identity. There were, also, some Peoples from the Caucasoid ethnic group, who were descendants of “Japheth”, that became descendants of “Shem” through their intermarrying/interbreeding with Hamitic-Semitic Peoples from the Negroid ethnic group who were descendants of “Jacob” and/or “Judah” and, as a result, produced Jewish Peoples of very light brown-skinned and yellow-skinned bloodlines that had settled in “Central Asia” and “Northwest Africa”. Many of these Hamitic-Semitic “European Jews”, some of whom had very little visible traits of the Negroid ethnic group but had Negroid ethnic blood types, had been “transported” to Southern Europe and some migrated, later, to Australia and the United States of America, while others were killed in the Jewish Holocaust by Hitler and his Nazi henchmen. These same Hamitic-Semitic “European Jews” of the Negroid ethnic group intermarried/interbred with “European Jews” of the Caucasoid ethnic group and therefore, they look more like those of the Caucasoid ethnic group. These Hamitic-Semitic “European Jews” are “True Jews”. We are intelligent enough to know that when

Adolph Hitler claimed to be a “Frankish Jew” (“European Jew of French-descent”) he was letting certain Peoples of the Caucasoid ethnic group know that he was a descendant of “Japheth”, and although he was also a descendant of “Shem” through “Esau” who was the progenitor of “Semitic Edomites”, he made it clear that he was NOT a descendant of the “Hamitic-Semitic Israelites”. The Peoples who are from the “Semitic Edomites” through “Esau” are NOT “True Jews”, because they are NOT from the “Hamitic-Semitic Israelites” through “Jacob”. Hitler was sending a world wide message of so-called “ethnic cleansing” for the “Revised German-Roman Empire”, which hoped to “exterminate” the “Jews” who had Negroid bloodlines that were “mixed” with Caucasoid bloodlines. Hitler wanted to, somehow, “wash” the “yellow, and brown and black colours” out of his so-called “superior, colourless, master race”. Interestingly, before European-Gentile standards of ethnic classification were “institutionalized” by European-Gentile Empires, the God of the Hebrews, in the “Bible”, Ordained that there would be three main “Family Heritages”, which included the Heritage of “Ham”, the Heritage of “Japheth” and the Heritage of “Shem”, within the ANCIENT HEBREW PERSPECTIVE. These three “Family Heritages” all had bloodlines that came from “Adam” and “Eve” through “Noah”. It is a genetically proved fact that “Adam” and “Eve” produced AB, BO, AO and OO blood types that began in Africa and then spread to “West Asia” (“Asia Minor”). Therefore, “Noah”, “Ham”, “Japheth” and “Shem” all had dark-brown, or reddish-brown, skin colours. Hence, there were NEVER any distinctions or different classifications made between them with regards to skin colour or hair texture or facial features, until the time of the Ancient Roman Empire! The Original, Biblical, “Family Heritages” were given in the order of the children’s ages, which would allow the oldest son to receive the biggest inheritance of “Royalty” and “Property” from his biological father. In the case of the generations of “Noah”, it was “Ham”,

the first-born, who received the biggest inheritance which included the Hamitic “Seat of Royalty” and all the Hamitic Lands including East Asia, Southeast Asia, South Asia, West Asia (Asia Minor), North Africa and East Africa. The second-born son of “Noah” was “Japheth”; and “Japheth” received the “Islands of the Gentiles” which included the Islands of the Mediterranean Sea and the Lands of Southern Europe. The third-born son of “Noah” was “Shem”; and “Shem” received the Semitic Land of “Arabia” (Genesis 10:1-32, KJV). I reiterate, there were NO different ethnic groups, and there were NO different races! There was ONLY one human family of three main extended families. Therefore, the extended family of “Ham” had reddish-brown-skinned Asians and dark-brown-skinned Africans in the Original God-Ordained “Seat of Royalty” on Earth. The extended family of “Japheth”, and the extended family of “Shem” did NOT receive the Original God-Ordained Hamitic “Seat Of Royalty” on Earth! It wasn’t until the extended family of “Shem” intermarried/interbred with the extended family of “Ham” in order for the God-Ordained “Seat of Royalty” to be passed over to a Hamitic-Semitic “Seat of Royalty” through which the Christ would be birthed on Earth. Do you now understand why the Edomite King Herod, and the German President Adolph Hitler did everything possible to try “exterminating” the “Jews” who came from the Original God-Ordained Hamitic-Semitic “Seat of Royalty” whether those “Jews” were of European-descent, or Arabian-descent, or Asian-descent or African-descent! Adolph Hitler knew, along with his Zionist Elitist Cohorts, that these “True Jews” were a barrier to him conquering and ruling the whole wide world along side of his Zionist Elitist Cohorts. This is, exactly, why certain European Empires decided to concoct the “systemic idea” of different races, one of which was supposedly superior to the others in a “graded” top-to-bottom “system”. The top race was supposedly the Caucasoid race, which had a “graded” top-to-bottom “system” within itself, that placed the

“Aryans” at the top, which was followed in the top-to-bottom order of “Northern European”, “Western European”, “Southern European”, “Eastern European” and “Indo-European” (“South Asian”). Hence, the so-called Caucasoid “race” (ethnic group), which was supposedly the “master race”, had a “master class” within itself which was supposedly above, and far more privileged, than the other “classes” within the Caucasoid “race”. The other so-called “races” which had other so-called “classes” were supposedly below, and far less privileged, than the other “races” and “classes” in a top-to-bottom graded “system”. This was the basis of the evil, systemic and racist “caste system” which was “institutionalized” by the British Empire in India before the Hamitic “brown man” named Mahatma Gandhi stood against it, and put a stop to it! Later, the Hamitic “black Man” named Martin Luther King Junior stood against it, and put a stop to it in the United States of America! We must accept the biblical proof that in Ancient Times some of the “Semitic” descendants of the “brown Man” called “Judah” intermarried/interbred with some of the “Hamitic” descendants of the “black Man” called “Ham” (“Canaan” – black Hamitic West Asians, and “Mizraim” – black Hamitic Egyptian Africans). Therefore, “Moses”, and “King David”, and “King Solomon” and the Christ (aka, “Je-sus”) did, in fact, have a “Hamitic” Lineage “mixed” with a “Semitic” Lineage in their “DNA”, which made them “Hamitic-Semitic” Peoples of “mixed” brown-skinned and black-skinned bloodlines. Later, the Ancient Roman Empire “adopted” the teachings of the Christ and “merged” them with the religion of Ancient Roman Mithraism, which became Ancient Roman Catholicism. The Ancient Roman Catholic Church “changed” the pictures and artifacts of the Israelite Hebrew Peoples of the “Bible” from brown-skinned and black-skinned images, into white-skinned images. However, the Israelite Hebrew Peoples of the “Bible” were, originally, a Hamitic-Semitic “mixed multitude” of “brown” and “black” Jewish Peoples whom would be

“classified”, by the so-called Caucasoid “race”, today, as Negroid Peoples. One of their descendants called “Mary” gave birth to the Christ who descended from the same Negroid Peoples that were also called “Jews” and/or “Israelites” by the so-called Caucasoid “race” (Exodus 12:38), KJV.

4. “The New Covenant of Israel” — BOTH, the “faith” in the Christ of Righteousness, AND the “works” in the Commandments of Righteousness make up the “New Covenant” that God Made with the “Remnant of Israel” (Jeremiah 31:31; Matthew 26:28; Luke 22:20; Hebrews 9:8-11; James 2:14-26).

The “Bible” shows what the ‘New Covenant’ of God’s Kingdom is, in Earth.

“In the same way, after the supper he (Messiah/Christ) took the cup, saying, This cup is the ‘New Covenant’ (Given to, the ‘Children of Israel’, and the ‘Children of Judah’, both of whom comprise the ‘Remnant of Israel’) in my blood, which is poured out (shed for the Atonement of sins) for you” (Luke 22:20, NIV).

“Behold, the days come, saith the LORD (YAHUWAH), that I Will Make a ‘New Covenant’ with the ‘House’ (aka, ‘Children’) of ‘Israel’ (‘Ten Northern Tribes of the Ancient Kingdom of Israel’), and with the ‘House’ (aka, “Children”) of ‘Judah’ (‘Two Southern Tribes of the Ancient Kingdom of Israel’): Not according to the ‘Covenant’ that I (YAHUWAH) Made with their (fore) fathers in the day that I (YAHUWAH) Took them by the hand to Bring them out of the Land of Egypt; which MY ‘Covenant’ they brake (aka, ‘disobeyed’), although I Was (like) a ‘Husband’ unto them, Saith the LORD (YAHUWAH): But this shall be MY ‘Covenant’ that I Will Make with the ‘House of Israel’; After those days, Saith the LORD (YAHUWAH), I Will Put MY (Moral) ‘Law’ in their inward parts (aka, ‘their minds’), and Will Write it (‘MY Moral Law’) in their hearts; and they shall be MY people” (Jeremiah 31:31-33).

“Because of all the evil of the ‘Children of Israel’ (‘Ten Northern Tribes of the Ancient Kingdom of Israel’) and of the ‘Children of Judah’ (‘Two Southern Tribes of the Ancient Kingdom of Israel’), which they have done to provoke ME (YAHUWAH) to Anger, they, their kings, their princes, their priests, and their prophets, and the men of Judah, and the inhabitants of Jerusalem. And they have turned unto ME (YAHUWAH) their back, and not their face: though I (YAHUWAH) Taught them, Rising up early and Teaching them, yet they have not hearkened to receive (MY) Instruction. But they have set their abominations in the (Spiritual)

House (of the LORD) which is Called by MY NAME (Yahuwah-sha/Yahusha) to defile it” (Jeremiah 32:32-34).

Cross References: Hebrews 8:6-13; 10:16; Jeremiah 33:25-26; Matthew 26:28; Mark 14:24.

Once again, anyone who makes the choice to be Baptized by the Messiah/Christ with his holy, “Spirit” (aka, “Holy Ghost”) into the Everlasting “Spiritual, Body” of the Messiah/Christ is now a “True Worshipper” (who worships ONLY “the Father” in Spirit and in Truth) inside the “Assembly of Israel” (“Church of Israel” / “Remnant of Israel”) who are, either, “True Jews” or “Truly Converted Gentiles”, that can be Baptized by the Messiah/Christ with God’s “Fire” (aka, “Holy Anointing”) into his Everlasting “Spiritual, Work” (aka, “Travelling, Teaching-Healing, School-Clinic, Outreach”), that “Betters” the spiritual, emotional, mental, physical AND socio-economic areas of one’s “whole being” (Matthew 3:11; Acts 1:2-8; 1 Corinthians 12:12-28).

Therefore, Father God Made an Everlasting “Covenant” with the direct descendants of “Jacob” (aka, “the Twelve Tribes of Israel”), which Father God “Renewed” seven times. It had Old “Signs” during the “Old Testament” times, and, later, had a New “Sign” during the “New Testament” times. Hence, Father God Gave the “New Covenant” a New “Sign”, which Father God “Sealed” with the holy, “Spirit” (“Holy Ghost”) of the Messiah/Christ until the Day of Redemption (“First Resurrection”).

The “New Covenant” between Father God and all historic humankind includes God’s Divine Provision, and God’s Divine Protection, and God’s Divine Providence, for those of us who learn, obey, and teach the Eight-fold Structure of God’s Kingdom, and Two-fold Status of God’s Righteousness within the New “Spiritual, Assembly of Israel” (aka, “New Spiritual, Church of

Israel”) that is in the New “Spiritual, Temple of God”, which is the “Spiritual, Body” of the Messiah/Christ, inside the “Spiritual, Heart” of Father God. Hence, the “New Covenant” between Father God and all historic humankind involves our “faith” of allegiance to the Christ of Righteousness AND our “works” of obedience to the Commandments of Righteousness (James 2:14-26; Hebrews 9:8-11).

[The “Original, Covenant” between Father God and “Adamite” humankind taught: “Thou shalt not transgress any Commandments of Father God; and if thou do, then, thou shalt bring death and evil upon thyself, and, if thou shalt not, then, thou shalt bring life and good upon thyself (Deuteronomy 30:15-20; Genesis 2:16-17; Hebrews 9:15-18). God’s “Original, Covenant” was a “Physical, Covenant” that was “Renewed” eight times: the eighth time being the “New Covenant” (aka, “New Testament”) that required the shed blood of the Messiah/Christ, which has, since then, become a “Spiritual, Covenant” between Father God and “Adamite” humankind like a “Spiritual, Wedding” between the Messiah/Christ (aka, “bridegroom”) and “Adamite” humankind who can become the sons of God (aka, “bride”) in Earth.]

Messiah/Christ is the “Mediator” of God’s “New Covenant” (“Renewed, Covenant”) in order for Father God to “Reconcile” us back to Him (2 Corinthians 5:18-21; 1 Timothy 2:3-6; Revelation 19:1-16; 21:2-4).

Every Aspect of Father God’s Divine Inheritance Plan for “Adamite” humankind under the “Old Covenant”, in the “Old Testament”, required a “Physical Foreshadow” of Father God’s “Spiritual Reality” under the “New Covenant”, in the “New Testament”. For instance, Father God’s “Gift of Grace” under the “Old Covenant”, came down from “on High” (aka, “Heaven”) to

Adam and Eve in the Physical Forms of Sacrificial Commandments, which would allow Father God to Protect, and Provide for, “Adamite” humankind, in the “Old Testament”. Father God’s “Gift of Forgiveness” (to Overlook), and “Gift of Justification” (to Pardon) came in the Physical Forms of Sacrificial Commandments, which included meat and drink offerings (sin and peace offerings, etc.), and carnal ordinances (shedding of blood through animal physical sacrifices, or shedding of blood through human physical circumcisions), in the “Old Testament”. Father God’s “Gift of Sanctification” (Purification) came in the Physical Forms of Sacrificial Commandments, which included diverse washings (different kinds of physical washings, including physical *temporal* “water baptisms”), in the “Old Testament”.

Conversely, Father God’s “Gift of Grace” under the “New Covenant”, in the “New Testament”, continues to come down from “on High” (Heaven) in the Spiritual State of God’s Supernatural “Metaphysical Mercy” emanating and pulsating from God’s Heavenly Throne into Earth, which began shortly after the Messiah/Christ Ascended, Spiritually, Heavenward.

In fact, Messiah/Christ taught the “Disciples” (aka, “Students”) of his Tenable Truth Teachings that we cannot put New (Spiritual) Wine into Old (Physical) Wineskins!

In other words, we CANNOT, and MUST NOT, “Mix” the Old “Physical Foreshadows” of the Physical “Old Covenant” with the New “Spiritual Realities” of the Spiritual “New Covenant”! You cannot “mix” the physical temporal “Sacrificial Law” with the Spiritual Everlasting “Moral Law” anymore, as far as the “new Covenant” is concerned. Hence, the physical temporal “Sacrificial Law” ended, BUT the Spiritual Everlasting “Moral Law” remains forever. The “New Covenant” of Father God Is “All Good”, “All Perfect”, and “All Spiritual”!

Father God Has Chosen to “Mix” certain Peoples with respect to their Ethnicity, BUT Father God Has Never and Will NEVER “Mix” His Truth with the lies of “Satan”!

Father God Has NEVER and Will NEVER “Make” His Physical to Be the same as or equal to His Spiritual.

Father God Has NEVER and Will NEVER “Place” His Physical Creation above His Spiritual Motivation, or Spiritual Inspiration. Hence, the “Moral Love” within Father God’s Spiritual Motivation, and Spiritual Inspiration, Is Above the “Mosaic Law” of God. HOWEVER, the “Mosaic Law” Had the physical temporal “Sacrificial Law” of physical temporal “Ceremonies”, BUT the “Mosaic Law” Has the Spiritual Everlasting “Moral Law” of Spiritual Everlasting “Testimonies”. Therefore, Father God’s Spiritual Everlasting “Testimonies” [including Father God’s Everlasting Holy Appointed Messiah, Father God’s Everlasting Holy Appointed Times, Father God’s Everlasting Holy Appointed Foods, and Father God’s Everlasting Holy Appointed Relations] Involve Father God’s Everlasting “Righteousness” that was NEVER abolished (Isaiah 51:1-6). In this “Way” you can see for yourself how the “New Covenant” that the God of Israel — Father God — Made with the “Remnant of Israel” (who have returned, or will return, to the God of Israel) includes, one’s “faith” of allegiance in the God of Israel’s Everlasting Christ of Righteousness, AND one’s “works” of obedience to the God of Israel’s Everlasting Commandments of Righteousness (James 2:14-26).

B.) Hebraic Fundamental Steps:

1. “Hebraic Sanctification” — By the “Grace” of our Father God, which is directly proportional to the level of our submission to our Father God, by way of the indwelling holy, “Spirit” (“Holy

Ghost”) of the Christ, and by way of the indwelling holy, “Fire” (“Holy Anointing”) of the Christ, working from within us and out through us as we allow (Matthew 3:11; Romans 8:29-30; Galatians 2:20).

The “Bible” shows the ‘Sanctified Tabernacle’ of God’s Kingdom, in Earth.

“Verily, verily, I say unto you, I am the ‘Door’ of the sheep” (John 10:7).

“I am the true ‘Vine’, and my ‘Father’ (‘God’) is the ‘Husbandman’ (aka, ‘Farmer’)... Now you are (spiritually) ‘clean’ through the Word (‘Message’) I have spoken (taught) unto you. Abide in me, and I in you. As the ‘branch’ cannot bear fruit (of my holy, ‘Spirit’ by) itself, except it abide in the ‘Vine’; no more can ye (bear fruit of my holy, ‘Spirit’ by your self), except ye abide in me... If ye abide in me, and my Words abide in you, ye shall ask what (blessed things) ye will, and it shall be done unto you” (John 15:1, 3-4, 7).

“That they may all be one; as THOU, Father, Art in me, and I in THEE, that they also may be one in Us; that the world may believe that THOU Hast Sent me. And the glory (aka, ‘Everlasting Spiritual Body’) which THOU Gravest me I have given (‘promised to’) them; that they may be one, even as We are one: I in them, and THOU in me, that they may be Made perfect in one (Divine Unity), and that the world may know that THOU Hast Sent me, and Hast Loved them, as THOU Hast Loved me. Father, I will that they also, whom THOU Hast Given me, be with me where I am (in THEE); that they may behold my glory (aka, ‘Everlasting Spiritual Body’), which THOU Hast Given me: for THOU Lovedst me before the foundation of the (Earth’s) world. O Righteous Father (God), the world hath not known THEE: but I have known THEE, and these have known that THOU Hast Sent

me. And I have declared unto them THY NAME (Y’sra-al-ah Al-alaha YAHUWAH, aka, ‘JEHOVAH El-elohe Israel’, or ‘LORD God Almighty of Israel) and will declare IT: that the Love wherewith THOU Hast Loved me may be in them, and I in them” (John 17:21-26).

Hence, the Messiah/Christ became the Open “Spiritual, Door” of God’s New “Sanctified Tabernacle”, and he became God’s New “Spiritual, Tabernacle”:

Hence, the Messiah/Christ ‘became’ the New “Tabernacle of God” (aka, New “Temple of God”, or New “House of the LORD”), when he was Resurrected from physical death, and, therefore, the people who, worship ONLY “The Father” (God) in

Spirit (aka, “holy, Spirit of Messiah/Christ”) and in Truth (aka, “God’s Holy Fire”/“God’s Holy Anointing”), and learn/obey the True Teachings of the Messiah/Christ, are the Peoples who, are added into the New “Spiritual, Assembly of Israel” (Jews and Gentiles), and are always in the New “Spiritual, Tabernacle of God”, which is, now, the “Spiritual, Body” of Messiah/Christ: the (Created, Spiritual) “Rock of God” (the Eight-fold Structure of God’s Kingdom, and Two-fold Status of God’s Righteousness), in Earth, as it is in Heaven. (Matthew 3:11; 6:9-10, 31-33; 7:21-27; 24:13-14; Luke 17:20-23; 1st Corinthians 10:1-4; 15:1-58; Acts 11:16; Psalm 23:6; Revelation 21:2-3).

In the Book of Hebrews, in the tenth verse of the ninth chapter, in the “Bible”, we read about “the time of reformation” (aka, “Spiritual Reformation”), which terminated the temporal “Levite Priesthood” and the temporal “Sacrificial Law”, that started at the moment the Messiah/Christ was “Resurrected” from his temporal physical death unto his Everlasting Spiritual Life and ended at the moment the temporal physical Temple in the city of Jerusalem was destroyed by the Gentile Roman Empire in 70 AD/CE.

In fact, in the year 70 AD/CE, on God’s Biblical Holy Day of “Passover”, God’s temporal physical Temple in Jerusalem was destroyed, and, exactly, three days later, in that same year of 70 AD/CE, the Messiah/Christ completely “Reformed” God’s temporal physical Temple into God’s Everlasting “Spiritual, Temple” within his (Messiah’s/Christ’s) “Spiritual, Body”. At that precise moment, the “Holy Way” for humans (who have, truly, “found” God’s Kingdom and Its Eight-fold Structure, and “found” God’s Righteousness and Its Two-fold Status) to enter into God’s New Everlasting “Spiritual, Holy of Holies” (aka, “Most Holy Place” in the New Everlasting “Spiritual, Temple of God”, which has become the New Everlasting “Spiritual, Body”

of Messiah/Christ), was “Made Manifest” (Matthew 6:33; John 2:19; John 4:21-24; Hebrews 9:8-11).

In the 1st Century AD/CE, the “Majority” of Peoples who followed/obeyed the Messiah’s Message: “This Gospel of the Kingdom of God” (from the time of the Messiah’s/Christ’s “Spiritual Resurrection” until the time of the Messiah’s/Christ’s “Spiritual Reformation”, were Israelites (“True Jews”) — “the hundred and forty and four thousand”/“144,000”, or “Saints” — who were “Sealed” during the ~37 years between the Messiah’s/Christ’s “Spiritual Resurrection”, and “Spiritual Reformation” (Revelation 3:6-12; Revelation 7:4; Revelation 14:1-12).

The “Bible” shows what the “Nature” of God’s Righteousness is, in Earth.

“Blessed (‘Predestinated’) are they which do hunger and thirst after (the) ‘Righteousness’ (of ‘God’s Nature’, and ‘God’s Power’): for they shall be filled” (Matthew 5:6). God’s Righteous “Nature” and God’s Righteous “Power” are United within God’s “Holy Spirit”. Hence, God’s “Holy Spirit” Is God’s “Nature”, and God’s “Power”.

It is NOT the third person of the Trinity! God’s “Holy Spirit” (Nature and Power of HIS Righteousness) CANNOT ever “Be” the “holy, Spirit” of Messiah/Christ who was God’s “1st Created holy, Angel Being” — “Angel of the LORD”, or “Angel of God” — the Mighty, God-Created Spirit Being who became a Jewish, God-Created human being. God’s Righteous “Nature” Manifests God’s Kingdom. Hence, God’s Kingdom will always be Manifested “from” God’s Righteous “Nature”.

The Divine “Righteousness” of God includes all of the Loving, Joyful, Peaceful, Merciful, Faithful, Unified and Just “Nature” of God that Lives in us, and Can Live out through us (through the holy, “Spirit” of Messiah/Christ in us), into all the Earth, when we choose to let the Righteous “Nature” of God Live out through our life – God’s “Righteousness” is, in fact, God’s “Nature”. Every human has been created in the Divine Spiritual “Image” of God in our spirit, and every human has been created with the Righteous “Nature” of God in our spirit, but we’ve all chosen to allow Satan to convince us and/or teach us how to make “inner blockages” to, God’s Kingdom, and God’s Righteousness, within us.

We are responsible for seeking, finding and embracing God’s “Kingdom”, which is already within us, in order for us to, learn how to receive God’s “Gift of Righteousness”, which is the holy, “Spirit” of His First-Resurrected Son, and allow God’s Kingdom to come forth from within us, out through us, so that we can resolve, and remove, (“expose and expel”) all of the unresolved negative emotions (fear, guilt, blame, shame, hatred, rage, envy, greed, self-righteousness, non-forgiveness, self-centred-pride or prejudice, etc.) of Satan’s “demonic blockages”, we let in us, that block/oppose the Manifestation of God’s Kingdom in Earth.

Hence, the “Nature” of God’s Kingdom includes the “Righteousness” of HIS “Holy Spirit” that, is in us, and MUST be working out through us throughout our Lifestyle.

The “Righteousness” of God’s “Holy Spirit” in us involves God’s “Righteous Nature”, which is the “Nature” of God’s Righteousness working in us and out through us, via the holy, “Spirit” of Messiah/Christ in us (Galatians 5:22-23).

Hence, whenever the True Messiah/Christ was teaching about a person’s “fruit” he was teaching about their inward “character” with respect to, whether, one’s “character” is being changed/transformed from their own carnal “unrighteous nature”

into God’s Holy “Righteous Nature” through the Indwelling and Cleansing of the holy, “Spirit” of Messiah/Christ in them, OR one’s “character” is NOT being changed/transformed into God’s Holy “Righteous Nature” (Matthew 7:16-23; Psalm 51:10-13; Hebrews 9:14; Titus 2:14; Titus 3:5; 1st John 1:7, 9; 2nd Corinthians 5:17-21; Galatians 5:22-26; 2nd Peter 1:2-12).

The “Bible” shows what the “Power” of God’s Righteousness is, in Earth.

“And lead us not into temptation, but deliver us from evil: For Thine Is The Kingdom (of God), and The Power (of God), and The Glory (of God), for ever. Amen” (Matthew 6:13).

God’s Righteous “Power” and God’s Righteous “Nature” are United within God’s “Holy Spirit”. Hence, God’s “Holy Spirit” Is God’s “Power”, and God’s “Nature”. It is NOT the third person of the Trinity! God’s “Holy Spirit” (Power and Nature) CANNOT ever “Be” the “holy, Spirit” of Messiah/Christ who was God’s “1st Created holy, Angel Being” (“Angel of the LORD” / “Angel of God” / “Spirit of the LORD” / “Spirit of God” / “Word of the LORD” / “Word of God”) — the Mighty, God-Created Spirit Being who became a Jewish, God-Created human being.

God’s Righteous “Power” Maintains God’s Kingdom. Hence, God’s Kingdom will always be Maintained by God’s Righteous “Power”. The “Power” of God’s “Holy Spirit” involves God’s “Righteous Power”, which includes the “Spiritual Talents” (aka, “Gifts”) of the holy, “Spirit” of Messiah/Christ — God’s Righteousness — dwelling in us, and working in us and out through us (Matthew 25:14-34; Isaiah 61:1-11; Isaiah 11:2-5; 1st Corinthians 12:7-13).

God’s “Holy Fire” is God’s “Holy Anointing” in those He “Chooses” to be “Baptized with Fire” by the Messiah/Christ in

order to be “Sent Out” into the world to preach Messiah’s Message: “This Gospel of the Kingdom of God” for a witness unto all nations; and then shall the end come! Hence, the “Evidence” of God’s “Holy Fire” is seen in the “Works” of God’s “Holy Anointing”, which is a “Portion” of God’s “Holy Presence” (Matthew 24:14; Luke 4:18, 36; Isaiah 10:27; 61:1-11; Acts 19:8, 11-12; 1st Corinthians 1:17; 2:12; 12:7-11; 15:20; Isaiah 11:1-2; 2nd Corinthians 1:21; 1st John 2:27-29; 1st Chronicles 16:21-27; Romans 1:1-6), BUT the “Power” that Messiah/Christ is referring to in Acts 1:8 is God’s “Authorization of Grace” (God’s “Authorization for Unmerited Help and Assistance”), He Gives to those He’s “Chosen” before their (“Holy Ghost”) SPIRITUAL Baptism.

The Main Question that we need to ask ourself AFTER we read and/or hear Messiah’s Message: “This Gospel of the Kingdom of God”, is as follows: “How can we obey (‘practice’) and/or teach (‘preach’) this Gospel of the Kingdom of God AFTER we read and/or hear it?”

Good News: “We can learn to obey (‘practice’) and/or teach (‘preach’) this Gospel of the Kingdom of God WHEN we, first, believe it with our mind and receive it into our ‘heart’, and, then, ALLOW the holy, ‘Spirit’ of Messiah/Christ to enter, and remain, in our ‘soul’ so that Father God Can Lead us thru the ‘Conversion Process’ that Transforms our character, and lifestyle.”

Many people are “Called” by Father God to read and/or hear Messiah’s Message: “This Gospel of the Kingdom of God”, BUT FEW people are “Chosen” by Father God to practice and preach Messiah’s Message: “This Gospel of the Kingdom of God”, because many people have NOT completed the “Conversion Process” that shows improvement in all areas of one’s life.

Many receive “Forgiveness” from Father God, because Father God Is Always Graceful, BUT FEW receive “Justification” (“Pardon for their mistakes”), or “Sanctification” (“Uprooting of the ‘inner causes’ of their mistakes”), from Father God, because they’ve NOT received the Indwelling of the holy, “Spirit” of Messiah/Christ, and, or, they’ve NOT completed the “Conversion Process”, and, or, they’ve NOT received the Indwelling of God’s “Holy Fire” (Anointing) that ‘Strengthens’ us for Father God’s ‘True Gospel Work’.

The “Conversion Process” has God’s Gifts: “Grace”, “holy, Spirit” (Christ), “Forgiveness”, “Justification”, “Sanctification”, and “Work” in us and out through us, which leads to, God’s Goals of “Salvation” (which is the “Conversion of our Character and Belief System, and, the Transformation of our Outward Lifestyle and/or Human Relations”), and “Ordination” (the Authorization by Father God to do His Work) before our physical life ends, and God’s Gifts of “Glorification”, “Coronation” and “Administration” after our physical life ends. All of God’s “Gifts” are all, now, “Spiritual”! Hence, the “Conversion Process” Exposes and Expels our inner negative limiting belief system and our inner negative unresolved emotions so that we can be, afterwards, “Saved” and then “Sent out” in this life, and “Redeemed” in the afterlife (Romans 8:16-30; 2nd Peter 1:1-10).

“Satan” has made all kinds of “inner negativity” (fear, guilt, blame, shame, racism, rage, revenge, rebellion, distrust, disrespect, non-forgiveness, envy, greed, self-righteousness, and the like) so that “inner negativity” can stop people from knowing Tenable Truth or from being “Sanctified” (Cleansed”) from “inner negativity”. Therefore, the “Gift” of “Sanctification” MUST take place before the “Goal” of “Salvation”! There can be NO “Salvation” UNLESS there is FIRST “Sanctification”! The “inner cup” of our “inner heart” MUST be “Cleansed”

(“Sanctified”) from the “inner negativity”, FIRST, BEFORE we can be “Saved” from the “Curse” (Matthew 23:26; Galatians 3:13).

2. “Hebraic Salvation” — By the “Grace” of our Father God, which is directly proportional to our level of submission to our Father God, through, BOTH, our faith of allegiance in the Christ of Righteousness, AND our works of obedience to the Commandments of Righteousness (Isaiah 51:1-6; Ephesians 2:7-8; James 2:14-26).

The “Bible” shows us who the ‘Family’ of God’s Kingdom is, in Earth.

“After this manner therefore pray ye: Our Father which Art in (the Most High) Heaven, Hallowed (Holy) BE THY Name (YAHUWAH, in Ancient Hebrew, aka, ‘JEHOVAH’ in Modern English). THY Kingdom Come. THY Will Be Done in Earth, as it is in (the Most High) Heaven. Give us this day our daily bread” (Matthew 6:9-11).

“And call no man your ‘Father’ upon the Earth: for (ONLY) ONE (Person) IS your ‘Father’, which IS in (the Most High) Heaven” (Matthew 23:9).

“Forasmuch then as we are the offspring of (Father) God, we ought not to think that ‘the Godhead’ is like unto gold, or silver, or stone, graven by art and man’s device” (Acts 17:29).

“For this reason I bow my knees before the Father, from Whom every family in heaven and on earth derives its name, that He would grant you, according to the riches of His glory, to be strengthened with power through His Spirit (of Christ) in the

inner man, so that Christ may dwell in your hearts through faith; and that you, being rooted and grounded in love, may be able to comprehend with all the Saints what is the breadth and length and height and depth, and to know the love of Christ which surpasses knowledge, that you may be filled up to all the fullness of God (Ephesians 3:14-19, NASB).

Father God “Is” ONLY One Person! Father God Is Supreme And Invisible Spiritual “Being”. Father God “Is” All Positive Motivation, and All Positive Emotion, both of which are Invisible “States of Being”. Father God “Is” Infinity, and Eternity, both of which are Invisible. NO one, and NO thing, “Caused” Father God to come into “Being”! Father God Has NO other person, or persons coequal to His Own One Self.

Wherever the “Bible” says Father God Has an “Image”, it should be translated as “Righteous Reality”, or “Spiritual Nature (aka, ‘Fruit of the Holy Spirit’), and Spiritual Power (aka, ‘Gifts of the Holy Spirit’), of Righteousness”. For example, Adam and Eve, originally, were Created by Father God in a likeness (spiritual portion) of the “Righteous Reality” of Father God. In this “Way”, Father God Created Adam and Eve with a spiritual portion of the “Spiritual Nature, and Spiritual Power, of God’s Righteousness”, before Adam/Eve took the “fallen nature” and “misguided power” from the “fallen angels”, the negativity of which has NOTHING to do with the “Righteous Nature”, OR “Righteous Power” of Father God! Hence, the INVISIBLE Spiritual Image of Father God CANNOT EVER be “visibly seen” by anyone! To “see God’s Face” is, obviously, a “metaphor”. Hence, Father God Has NO Visible Physical Image; and He Commands that we make NO Visible Physical Image of HIM, because there is NO such thing!

Father God “Is” the Designer, and Cause, and Creator, and Ruler of the entire Universe. Father God “Is” Immutable, and

Immeasurable. Father God “Is” All Powerful, All Knowing, All Present, and All Good. Father God “Is” Self-Existent outside of the entire Physical Universe! Father God Has, also, Chosen to “Be” Co-Existent inside of the entire Physical Universe, inside the “spirit” of each historic human being, and inside the “spirit” of each angel being. Father God CANNOT “change” His Own One Self into any human being, or angel being! Father God Can Manifest His “Righteousness” (His “Righteous Spiritual Nature”, and “Righteous Spiritual Power”) in to, and out through, historic human beings, and angel beings. Father God Can Manifest a “Spiritual Portion” of His “Spiritual Light” into the Universe, especially in Earth, as His “Shakinah” (“Holy Fire”) that can Consume, or not Consume, things or people depending upon God’s Good Will.

The 1st Heavenly “Son of God” was the “Angel of God”, aka, “Angel of the LORD”, as spoken of in the “Old Testament”, called “the firstborn of every creature”, who became a humble human being, as written about in the “New Testament” (Exodus 3:2; 14:13; Colossians 1:15; Isaiah 7:14; Revelation 3:14; Matthew 1:20-23; Luke 1:35; John 1:14-18). The other Heavenly “Sons of God” were the “Heavenly Host”, or “Holy Angels of God”, whom God Created after He Created the 1st “Son of God” (Genesis 6:1-2; Luke 2:13). The Earthly “sons of God” are human beings all of whom God Created after He Created all of the Heavenly “Sons of God” (Genesis 1:26-27; Genesis 2:21-22). Together, Father God, and the 1st Heavenly “Son of God”, and the other Heavenly “Sons of God”, and the Earthly “sons of God”, all comprise what the “Bible” refers to as “the Godhead”, which is an English Term for “the Family of God”. Each person within “the Family of God”, aka, “the Godhead”, is an Individual in the Collective Community of God’s Offspring, and God’s Household. Human beings can become as/like the “Holy Angels of God”, which are the Holy, Heavenly “Sons of God”, in the

First Resurrection when the Messiah/Christ Comes to Earth with many of the Holy, Heavenly “Sons of God” in order to Defeat the enemies of God, and Restore the Kingdom of Israel to the way it was in King David’s days, and Re-Establish the “Kingdom of God” in Earth, as it is in Heaven (Matthew 6:10; Matthew 22:30; James 1:17-18; Psalm 8:4-5; Hebrews 2:5-17; 1st John 3:1-2).

Father God IS THE SUPREME BEING WHO “IS” ONLY ONE PERSON! Father God HAS NEITHER a coequal person, NOR coequal persons, in HIS OWN ONE SELF (Genesis 1:1; Genesis 2:1-4, 7-8, 21-22; Exodus 6:2-3; Numbers 23:19; Isaiah 40:12-14; Isaiah 40:17; Isaiah 40:25; Isaiah 42:5-7; Isaiah 43:10-11; Isaiah 44:6-8; Isaiah 45:2-6; Isaiah 45:18-22; Isaiah 46:5, 9; Isaiah 48:1-2).

Therefore, when the “Bible” is speaking about “the Godhead”, it is ALWAYS referring to “the Family of God”, which includes: 1, “Father God”, 2, the 1st Heavenly “Son of God” (the Messiah/Christ), 3, the other Heavenly “Sons of God”, and, 4, the Earthly “sons of God” who can become like the Heavenly “Sons of God” in the First Resurrection when Messiah/Christ Returns to Redeem those of us in the 1st Resurrection, and Re-Establish God’s Kingdom in Earth, as it is in Heaven (Matthew 6:10, 33;; Matthew 22:30; 24:13-14; Revelation 20:4-6; 1st Corinthians 15:1-8).

However, Father God Knows that, there are Heavenly “Sons of God” who have “ran away” from Father God’s Family and Household, and there are Earthly “sons of God” who have “ran away” from Father God’s Family and Household. Father God has

NOT and will NOT “desert” any of his children, as we can see for ourself in the “parable of the prodigal son” (Luke 15:11-32).

Father God did NOT “chase after” His “run away child” and Father God did NOT “desert” His “run away child”. Father God did NOT “condemn” His “run away child”! In fact, when the “run away child” chose to “return” to the Family and Household of Father God, it was a time for Father God to “Celebrate” and then “Forgive”, “Justify”, “Sanctify” and “Save” his “child” who chose to “repent” and “return” to Father God’s Family and Household.

In this “Order”, Father God Has Allowed for His Earthly “sons of God” (and “daughters of God”) to “repent” and “return” to Father God so that they may be “Forgiven”, and “Justified”, and then “Sanctified”, and then “Saved” by the Grace of Father God through their “faith” of allegiance in the Christ of Righteousness AND their “works” of obedience to the Commandments of Righteousness (Matthew 24:13; James 2:14-26).

Therefore, according to the Original Ancient Hebrew Perspective, a person is “Saved” from the “Curse” AFTER he, or she, successfully completes God’s “Conversion Process”: 1, “Forgiveness”, 2, “Justification”, 3, Sanctification”, and 4, “Salvation” (“Transformation”). Hence, “Salvation” is a “Destination”! Messiah/Christ was Created, and Sent, by God to Earth to, be the “Sacred Substitution” for the imposed and temporal “Sacrificial Law”, and be the “Righteous Representative” and the “Perfect Example” of how we can have the Right Kind of Character, and Right Kind of Lifestyle (through the Right Kind of Faith, and the Right Kind of Works), to Learn, Obey and Teach the Eight-fold Structure of God’s Kingdom and the Two-fold Status of God’s Righteousness, which Yield a “New and Improved Life” before our physical life ends, and an “Everlasting Perfect Life” after our physical life ends.

[By the way, we DON’T go to Heaven when we die, because the “Bible” tells us we will sleep in the Earth’s grave (“hell”) of death until, either, the First Resurrection of Everlasting Life when the Christ Returns to EARTH, or, the second resurrection of Continuing Death when the 1,000-year reign of the Christ is over. Hence, the grave (“hell”) of death has two levels: the upper level is for those awaiting the First Resurrection of Preserving their souls in an Everlasting Body, and the lower level is for those awaiting the second resurrection of Recycling their souls in another temporal body. The “lake of fire” (“gahennah”) takes place after the second resurrection, at which time those who are raised in another temporal body have their bodies burned in the “second death” and their souls will return to the lower level of the grave (“hell”) of death (Job 19:25-26; Psalm 16:9; Psalm 17:15; Isaiah 45:23; Luke 14:14; John 5:28, 29; Acts 24:15; 1st Corinthians 15:20-23, 52; Ephesians 1:19-20; 1st Thessalonians 4:16; Revelation 20:4-5, 15; Revelation 21:8).]

Messiah/Christ stated: “Salvation is of the Jews” (John 4:23). 

Nieuwe opperrabbijn Israëlich leger: Verkrachting Arabische vrouwen toegestaan

Avigdor Lieberman, Israël's nieuwe minister van Defensie, heeft een serie militaire promoties aangekondigd, waaronder die van de "Rape-Rabbijn" Eyal Krim (Eyal Qarim).

Eyal Krim, wordt de nieuwe opperrabbijn van het Israëliisch leger, de Israeli Defense Force (IDF). Krim is meer dan controversieel. Volgens de nieuwe opperrabbijn is het toegestaan voor een Israeliet om vrouwen van een vijandige stam te verkrachten.

In een [interview](#) met een religieus tijdschrift in het Hebreeuws reageerde Krim op de vraag of het volgens het Boek van Deuteronomium toegestaan is voor Israëlieten om vrouwen van vijandige stammen te verkrachten en hoe dit zich tot modern militair beleid verhoudt.

Krim verklaarde in het interview dat het toegestaan is voor joodse soldaten om aantrekkelijke Arabische vrouwen van de vijanden te [verkrachten](#) omdat dit het moraal van de soldaten zou verhogen en dit bij zou dragen aan het groter goed van de natie in het bereiken van haar militaire doelen.

Executie Palestijnen

Volgens de nieuwe opperrabbijn van het IDF zijn gewonde Palestijnen geen mensen, maar beesten die [geëxecuteerd dienen te worden](#), een criminele daad waar de IDF-soldaat Elor Azarya voor vervolgd gaat worden, omdat hij onlangs een gewonde Palestijn executeerde. De

beelden van die executie gingen de wereld over, wat leidde tot een storm van kritiek.

Volgens Rabbijn Krim is homoseksualiteit een gevaar voor de natuurlijke balans en zouden vrouwen niet het recht moeten hebben om te getuigen voor een rechtbank. Ook zou het voortrekken van joden bij arbeidsplaatsen met meerdere geschikte kandidaten geen racisme zijn, omdat het "De jood ten goede komt".

"Christendom is afgoderij"

Het nieuwe testament is in de ogen van de nieuwe opperrabbijn van het IDF afgoderij: "Als een jood een kopie van het Nieuwe Testament vindt, dan dient hij het te verbranden en te behandelen met extreme wreedheid. Die actie is goed en rechtmatig omdat de christelijke doctrine wordt beschouwd als afgoderij en schadelijk voor de wereld."

Volgens het IDF, die reageerde op vragen van +972MAG op de opmerkingen die de Rabbijn in het verleden heeft gemaakt, zouden de uitspraken van de rabbijn uit zijn context zijn gehaald. "Krim was niet in actieve dienst toen hij die regels verkondigde en bovendien zijn uw vragen respectloos tegenover het IDF, de Israëliische Staat en de joodse religie en om die reden zullen uw vragen niet langer beantwoord worden door ons", aldus een verklaring van het IDF.
